SPECIAL WARRANTY DEED

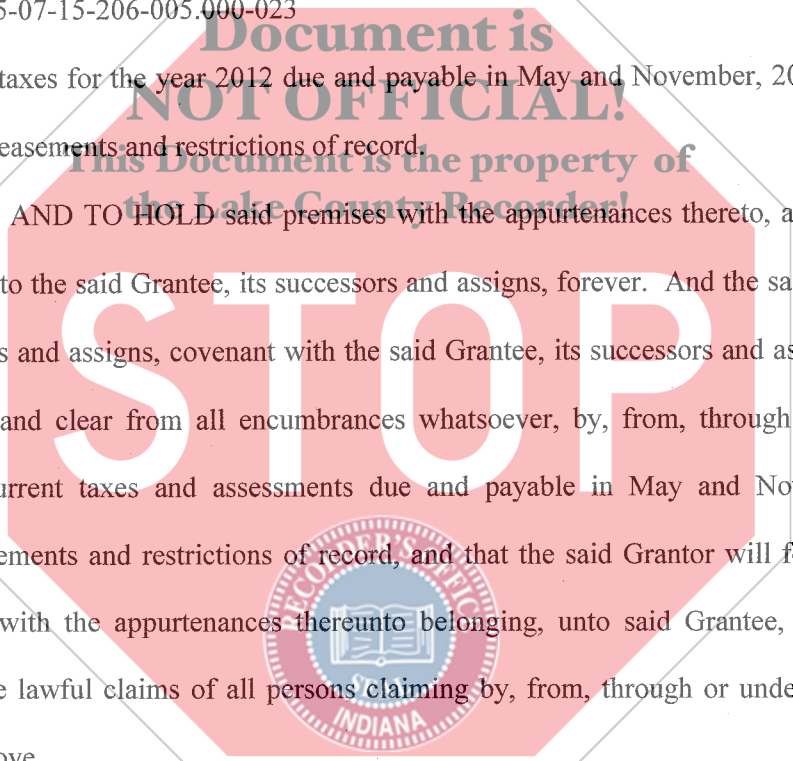

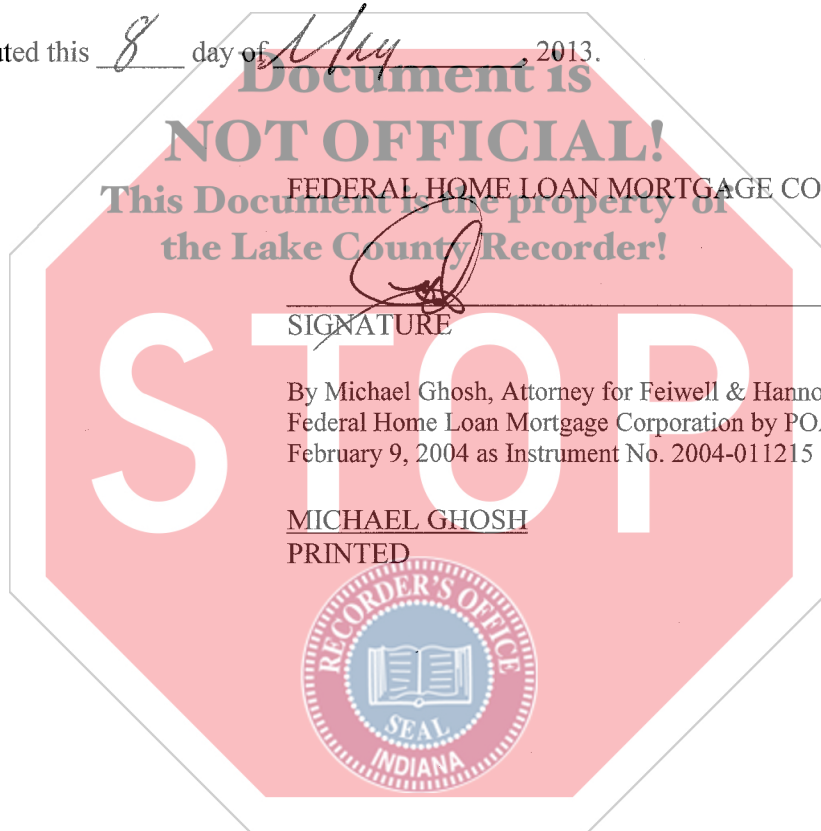

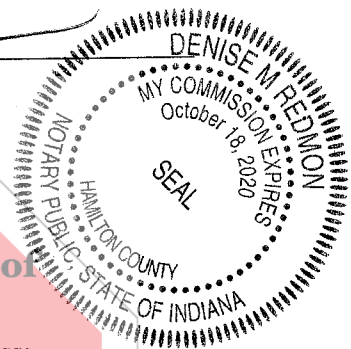
