I, Lorraine Brown, being duly sworn, state as follows:

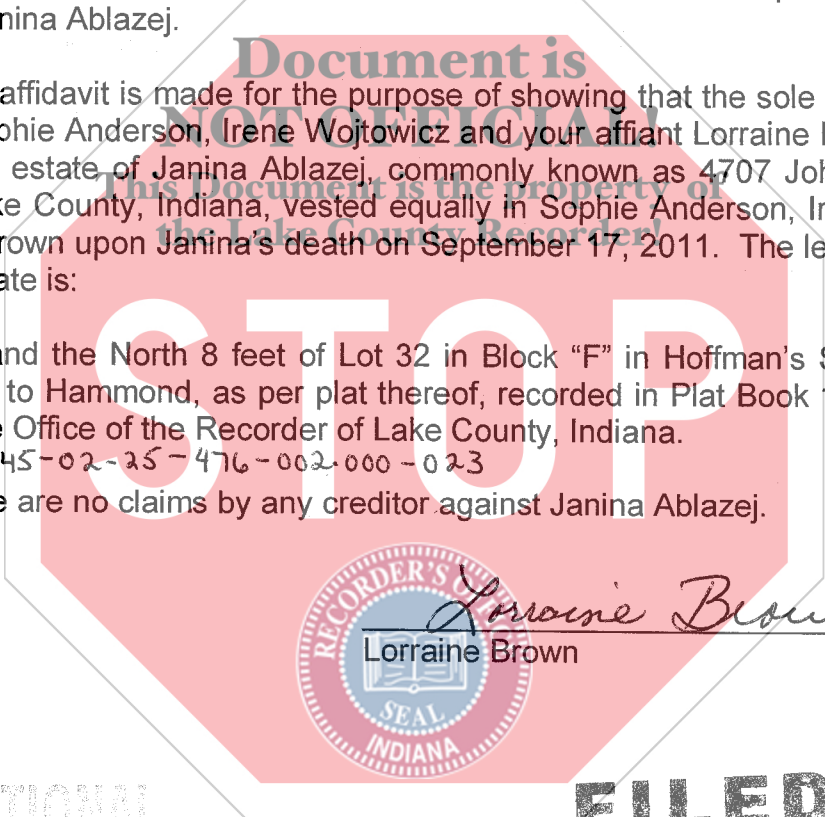
1. She is the daughter of Janina Ablazej who died September 17, 2011, a resident of Lake County, Indiana. Janina Ablazej died intestate.


