**AFFIDAVIT OF SURVIVORSHIP AND MEMORANDUM OF
RESTATEMENT OF THE FLETCHER LIVING TRUST**

4. That Lorraine A. Fletcher died on October 6, 2011, that all expenses and taxes incurred in connection therewith have been paid in full and that there are no unpaid bills left by reason of her death.

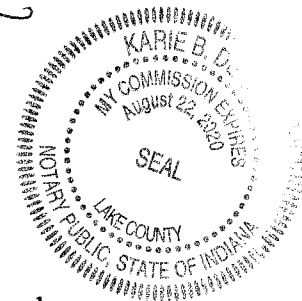

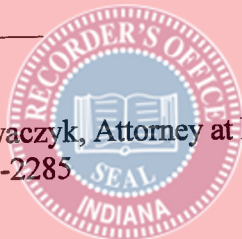
