

**REVOCATION OF POWER OF ATTORNEY**

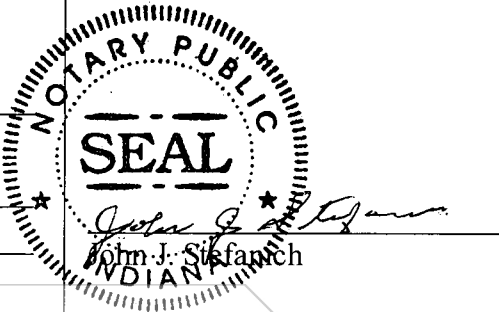
