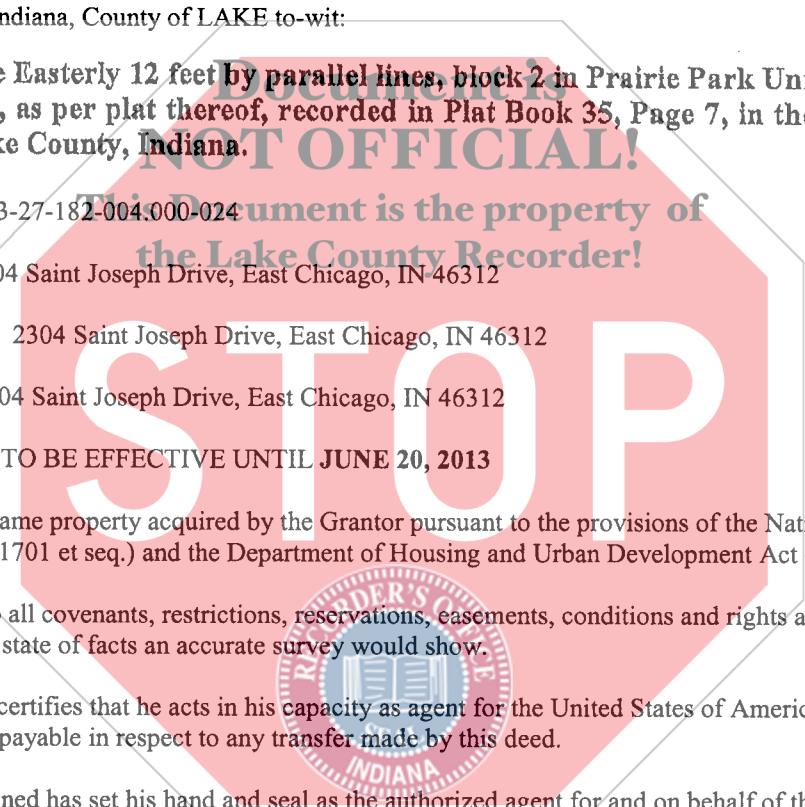
THIS DEED IS NOT TO BE EFFECTIVE UNTIL JUNE 20, 2013
