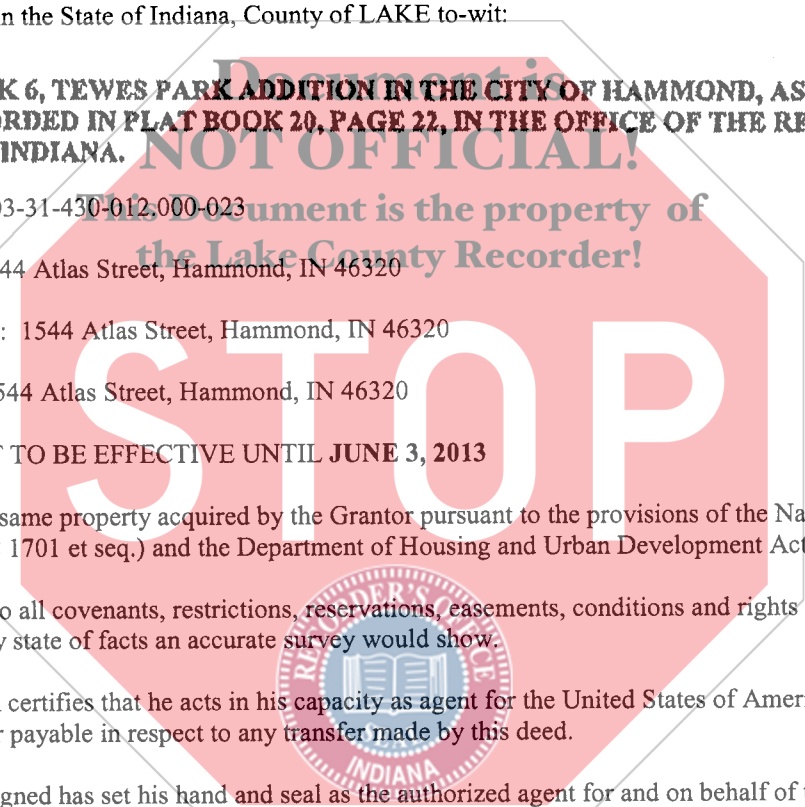
THIS DEED IS NOT TO BE EFFECTIVE UNTIL JUNE 3, 2013
