AFFIDAVIT OF SURVIVORSHIP

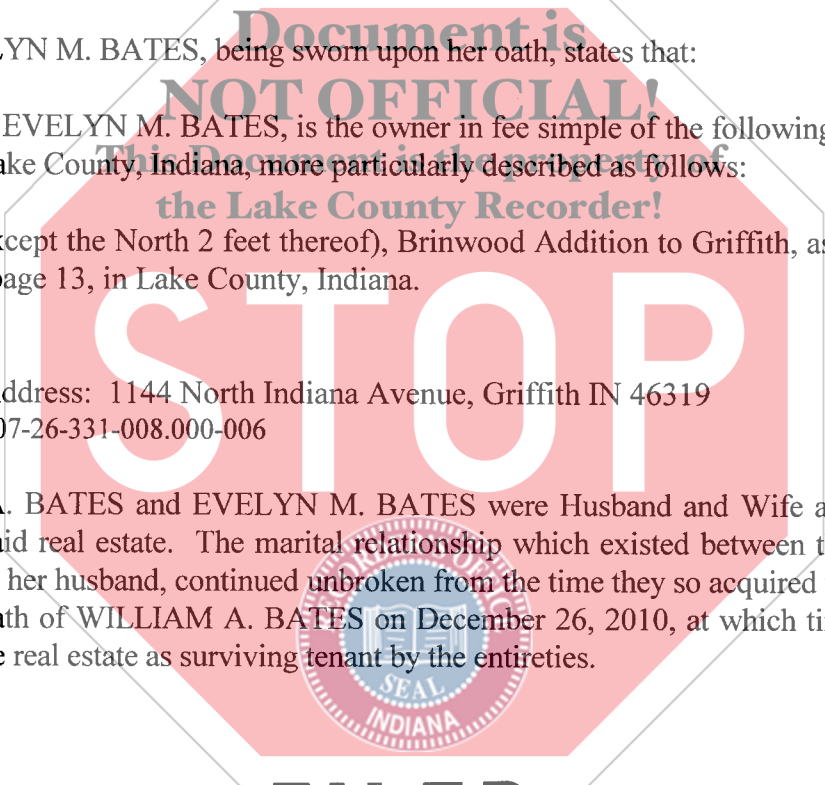
Comes now EVELYN M. BATES, being sworn upon her oath, states that:

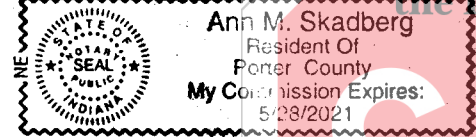
