Affidavit of Aliases

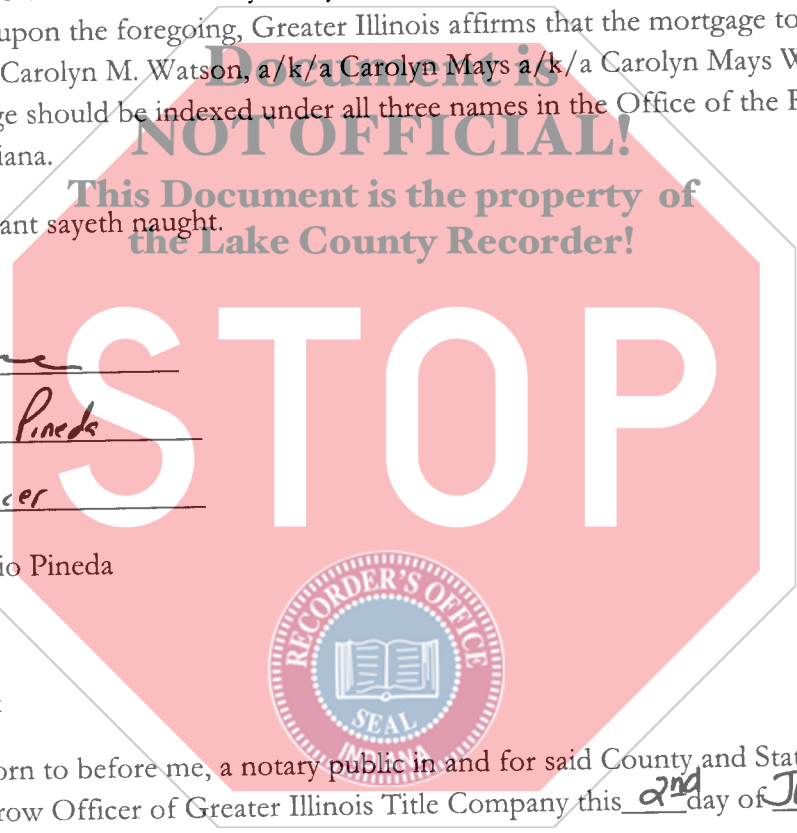

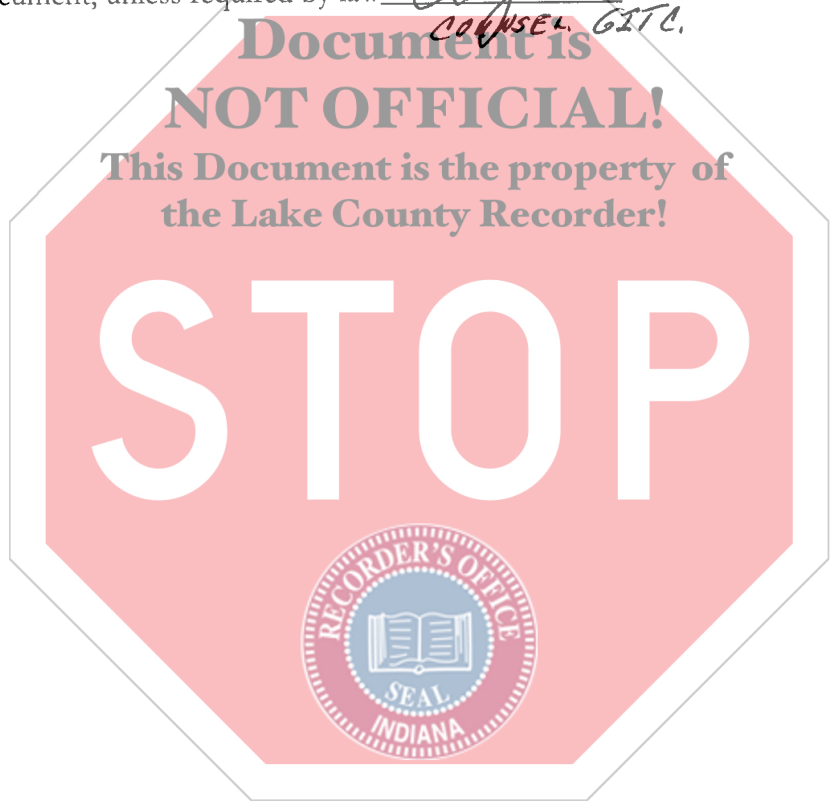
