This restriction shall terminate immediately upon conveyance at any foreclosure sale related to a mortgage or deed of trust.

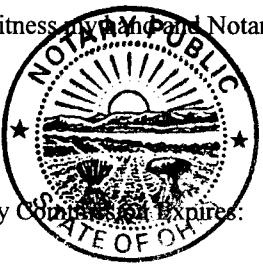

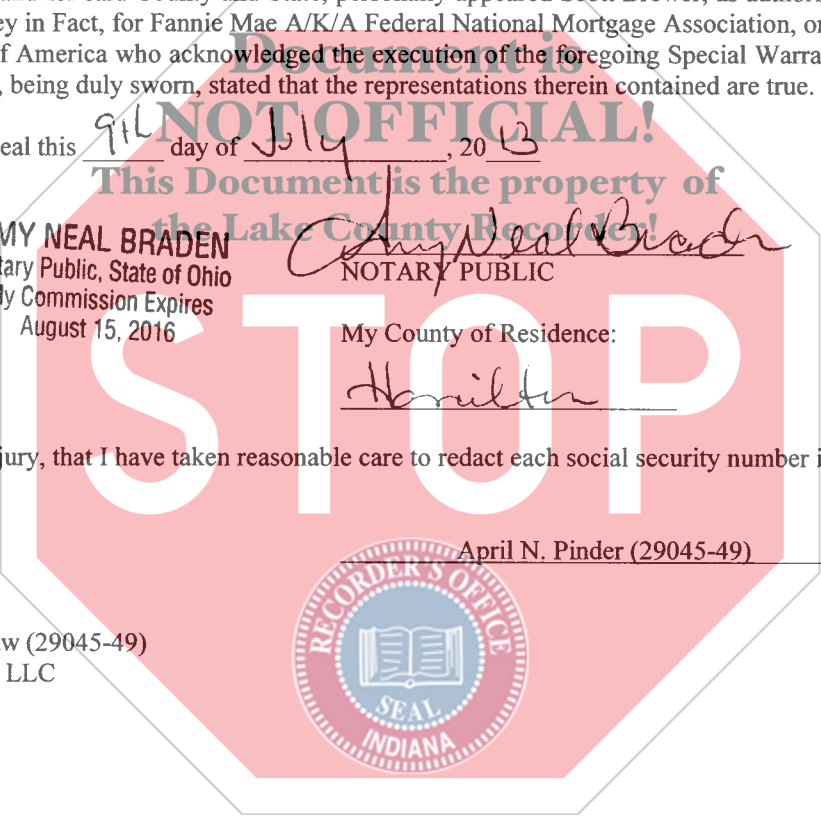
