Charles Edward Schultz, 6365 Maryland Ave., Hammond, IN 46323, son of decedent;

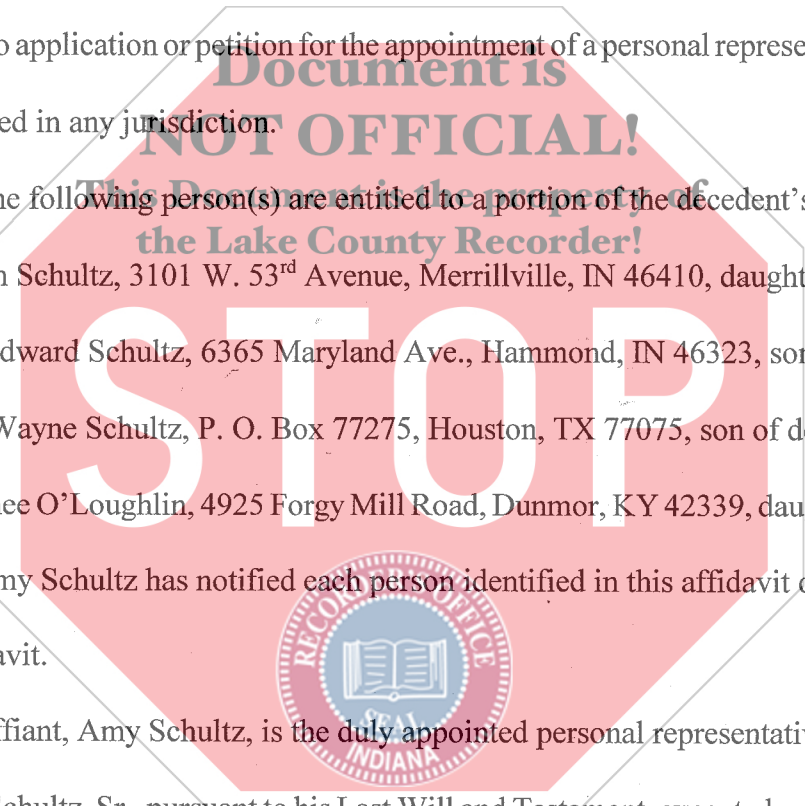

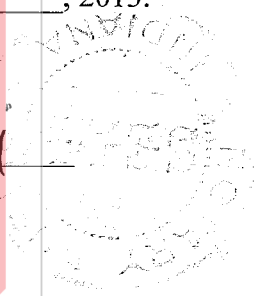
