
SUBORDINATION AGREEMENT

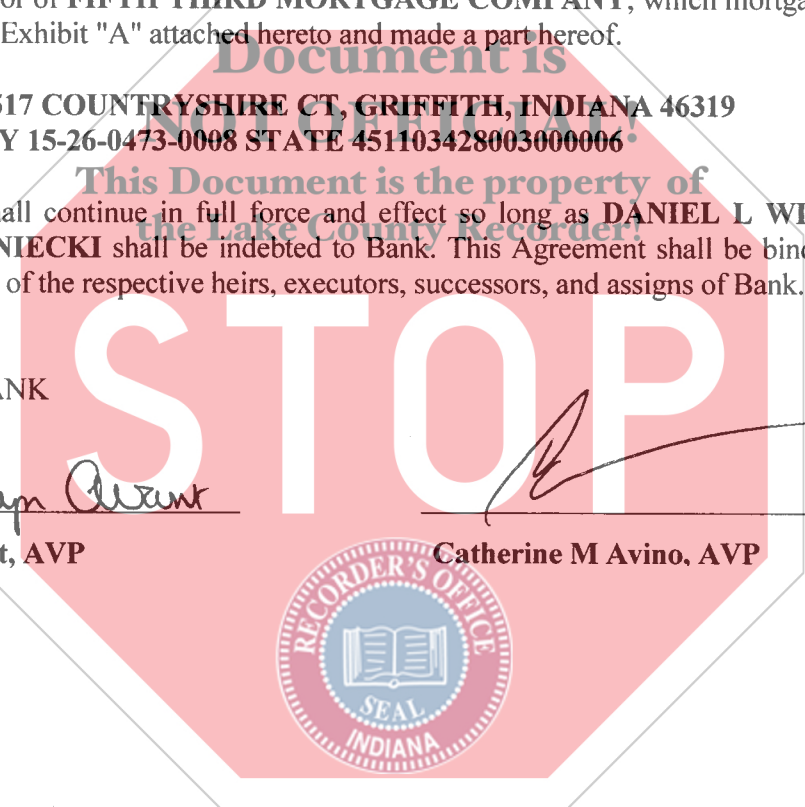

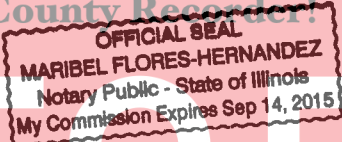

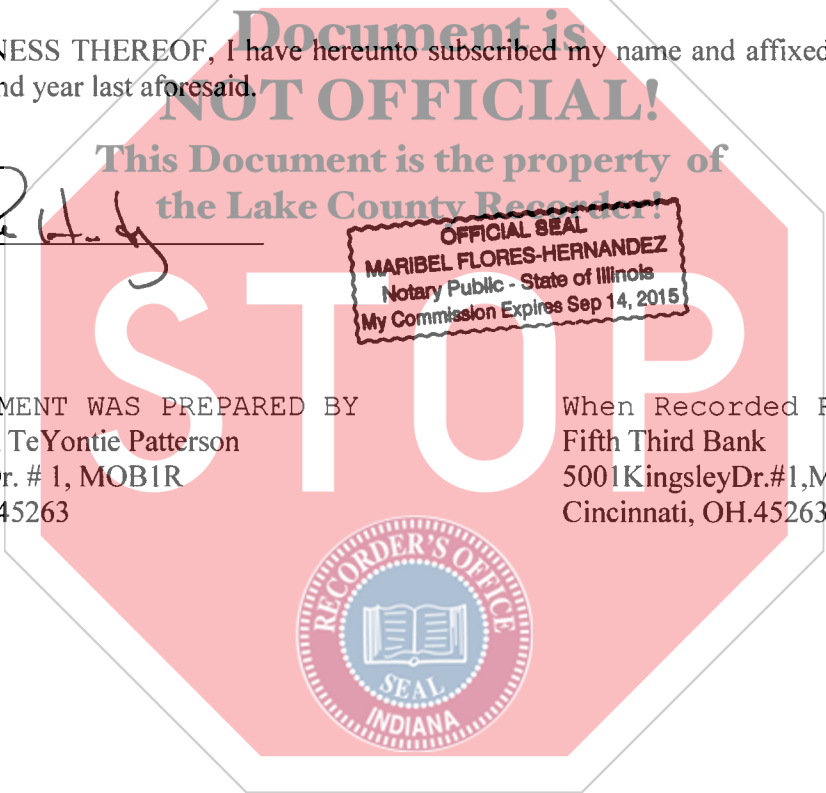
