Some Auditor and Recorder offices require the second page of the ATRE to be notarized, simply disregard the page if this is not required by the county in which your manufactured home is located.

Remember the ATRE process does not complete securing the lenders interest until the ATRE packet is recorded in the county where the property is located.

The Auditor's office endorses the ATRE and sends the endorsed ATRE along with the retired title application to the recorder's office for the proper recording.
