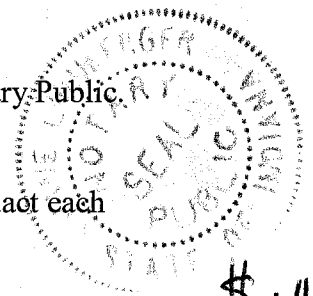
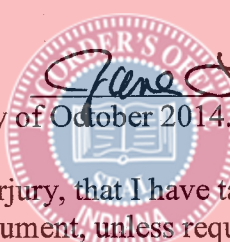

A PARCEL OF LAND IN THE W 1/2 OF THE NW 1/4, SECTION 21, LYING NORTHERLY AND WESTERLY OF DEEP RIVER, DESCRIBED AS COMMENCING AT A POINT OF INTERSECTION OF THE NORTH LINE OF THE NW 1/4 OF SAID SECTION 21, WITH EAST RIGHT OF WAY LINE STATE ROAD # 51, WHICH POINT IS 60 FEET EAST OF THE NW CORNER OF SAID SECTION 21, THEN SOUTH ALONG SAID EAST RIGHT OF WAY LINE AND PARALLEL TO THE WEST LINE OF SAID SECTION 21, A DISTANCE OF 1,449 FEET TO POINT OF BEGINNING OF PARCEL, THENCE EAST AND PARALLEL TO THE NORTH LINE OF SAID NW 1/4 OF SAID SECTION 21, A DISTANCE OF 290 FEET TO THE EDGE OF DEEP RIVER, THEN SOUTHWESTERLY ALONG THE EDGE OF DEEP RIVER TO ITS INTERSECTION WITH THE EAST RIGHT OF WAY LINE OF SAID STATE ROAD # 51, THENCE NORTH ALONG THE EAST RIGHT OF WAY LINE A DISTANCE OF 420 FEET TO THE POINT OF BEGINNING IN SECTION 21, TOWNSHIP 36 N, RANGE 7 W, OF THE SECOND PM, IN LAKE COUNTY, INDIANA.
