The court further finds as follows:

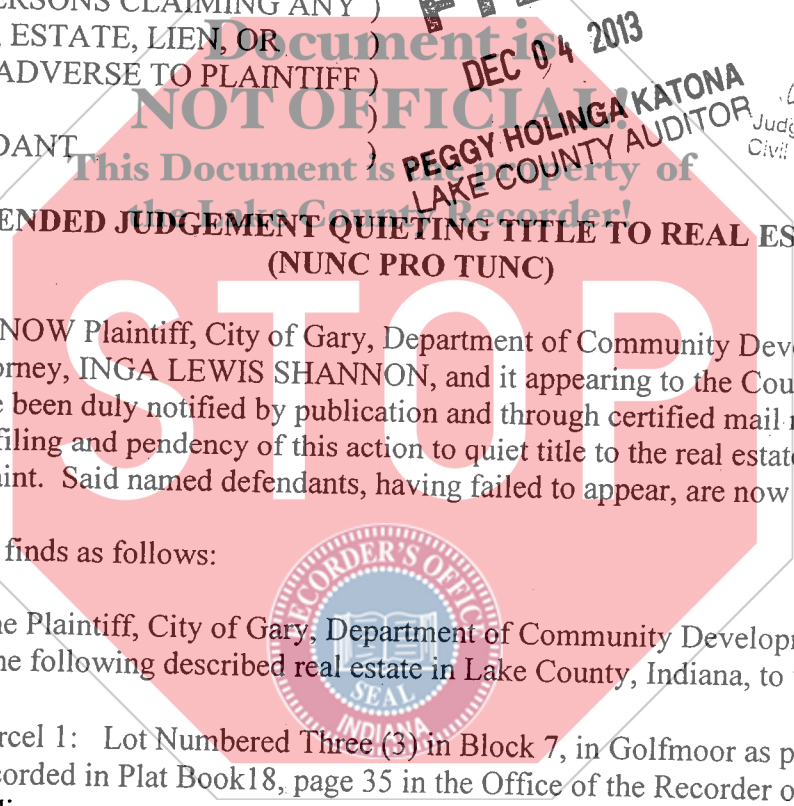
