The court further finds as follows:

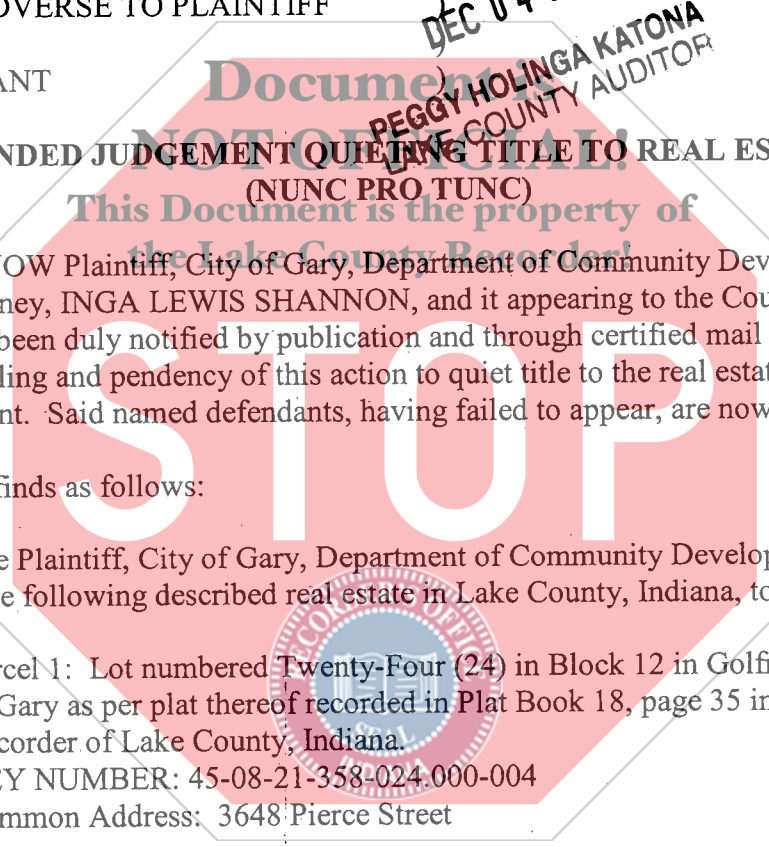

1. The Plaintiff, City of Gary, Department of Community Development, the owner in fee simple of the following described real estate in Lake County, Indiana, to wit:

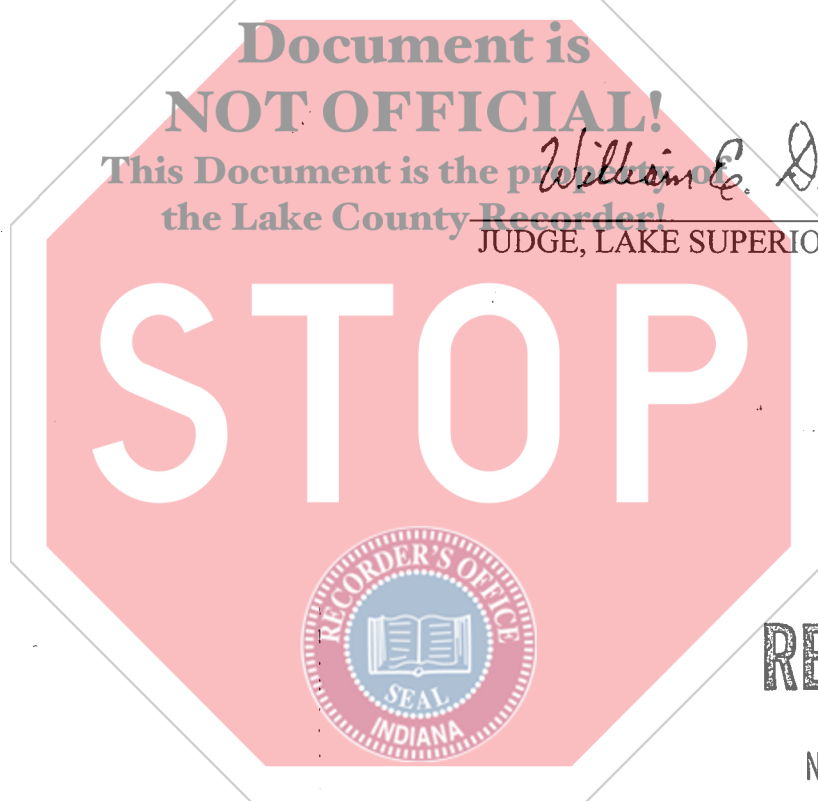
