# TAX DEED

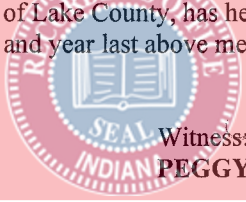


