SPECIAL WARRANTY DEED

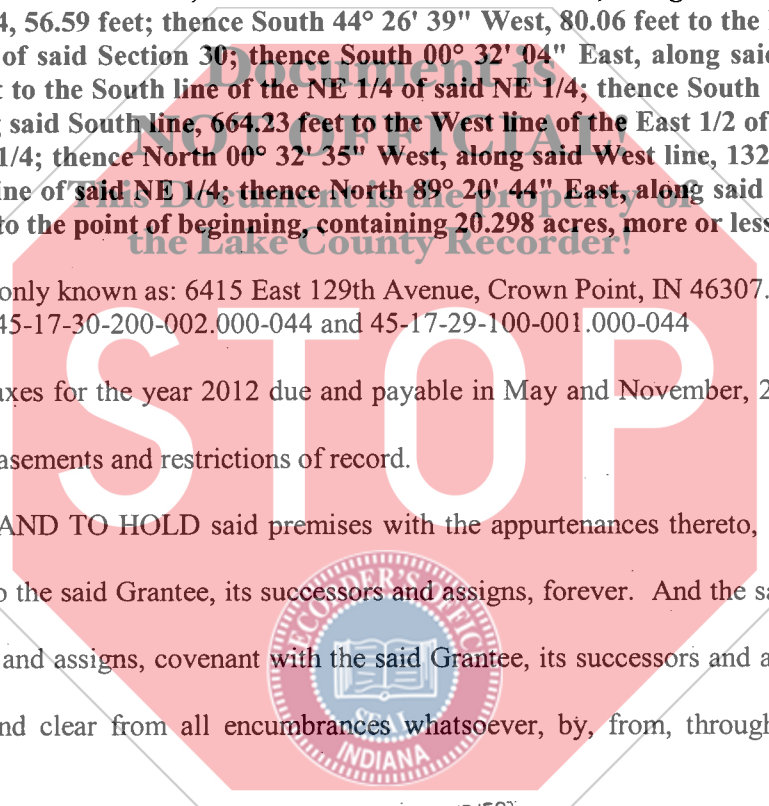

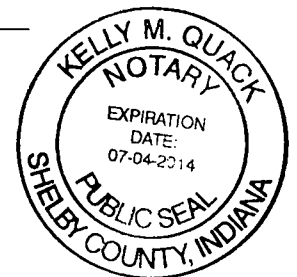
