SURVEYOR'S REPORT:

THIS PLAT REPRESENTS AN ORIGINAL SURVEY OF ALL THE LAND DESCRIBED IN DOCUMENT 2013 004932 THAT LIES SOUTH OF THE STONY RUN DITCH WEST BRANCH AND STONY RUN DITCH.

THEORY OF LOCATION: SECTION MEASUREMENT WAS PERFORMED ON THE FOUND SECTION CORNER MONUMENTS PERPETUATED BY THE LAKE COUNTY SURVEYOR'S OFFICE. ADDITIONAL MONUMENTS WERE FOUND ALONG SECTION LINES AND ARE SHOWN HEREON. A RAILROAD SPIKE WAS FOUND AT THE NORTH QUARTER CORNER AND HELD FIXED AS SUCH. THE POSITION OF THE SOUTH QUARTER CORNER (SOUTHWEST CORNER OF THE SUBJECT PARCEL) WAS CALCULATED USING THE DISTANCE SHOWN ON AN UNDATED, UNSIGNED PLAT OF SURVEY TITLED THE WILLIAM NILES EAGLE CREEK FARM SURVEY WHICH WAS FOUND IN THE LAKE COUNTY SURVEYOR'S OFFICE SECTION FILES. A STRAIGHT LINE WAS PRODUCED NORTH-SOUTH BETWEEN SAID NORTH QUARTER CORNER AND SOUTH QUARTER CORNER TO CALCULATE THE POSITION OF THE WEST LINE OF THE EAST HALF OF THE SECTION. THE CALCULATED LINE AGREED WELL WITH A STONE AND WOODEN POST FOUND AT THE CENTER OF SECTION AS WELL AS REMNANTS OF FENCE POSTS FOUND NORTH AND SOUTH OF SAID CENTER OF SECTION. THE CENTER LINE OF STONY RUN WEST BRANCH AND STONY RUN DITCH WERE MEASURED THIS SURVEY. THE MEASURED POSITIONS WERE USED ALONG WITH A DIGITIZED AERIAL MAP TO APPROXIMATE THE CENTER LINE OF SAID DITCHES FOR THE PURPOSES OF PREPARING THE LEGAL DESCRIPTION AND FOR CALCULATING THE SUBJECT PARCEL AREA, BOTH SHOWN HEREON.

A: AVAILABILITY AND CONDITION OF REFERENCE MONUMENTS: UNLESS OTHERWISE STATED ON THIS PLAT, FOUND MONUMENTS WERE UNDISTURBED, AT OR NEAR GRADE, IN GOOD CONDITION, AND OF UNKNOWN ORIGIN.
UNCERTAINTIES IN THE LOCATION OF FOUND MONUMENTATION WAS 1.0' IN A NORTH-SOUTH DIRECTION AND 1.0' IN AN EAST-WEST DIRECTION.

B: NO APPARENT UNCERTAINTIES RESULTED DUE TO SUBSTANTIAL OBSERVED OCCUPATION OR POSSESSION LINES. OVERHEAD UTILITY WRES ALONG WITH TWO HIGH TENSION TOWERS WERE LOCATED ON THE SUBJECT PARCEL AND SHOWN HEREON. NO DOCUMENT WAS SEARCHED FOR OR PROVIDED WHICH WOULD EXPLAIN SAID USE. A TELEPHONE BOX, A TELEPHONE MANHOLE, AND VARIOUS ROAD SIGNS WERE LOCATED NORTH OF THE NORTH 20 FOOT RIGHT OF WAY LINE ALONG THE SOUTH SIDE OF THE SUBJECT PARCEL AND ALL ARE SHOWN HEREON WITH THE POSITIONAL RELATIONSHIPS TO THE PROPERTY LINES.

C: NO APPARENT UNCERTAINTY RESULTED DUE TO RECORD DESCRIPTIONS.

D: THE RELATIVE POSITIONAL ACCURACY (DUE TO RANDOM ERRORS IN MEASUREMENTS) FOR THIS SURVEY, BASED ON EQUIPMENT AND PROCEDURES USED, WAS WITHIN THE ALLOWABLE (0.26 FEET PLUS 200 PARTS PER MILLION) FOR A RURAL SURVEY, PER 865 IAC 1-12-7.




