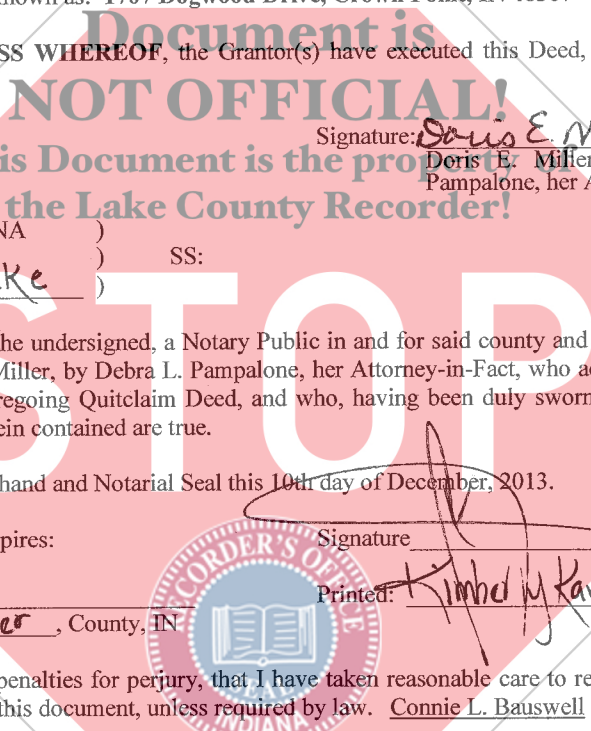
QUITCLAIM DEED

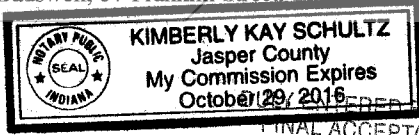
