**SPECIAL WARRANTY DEED**

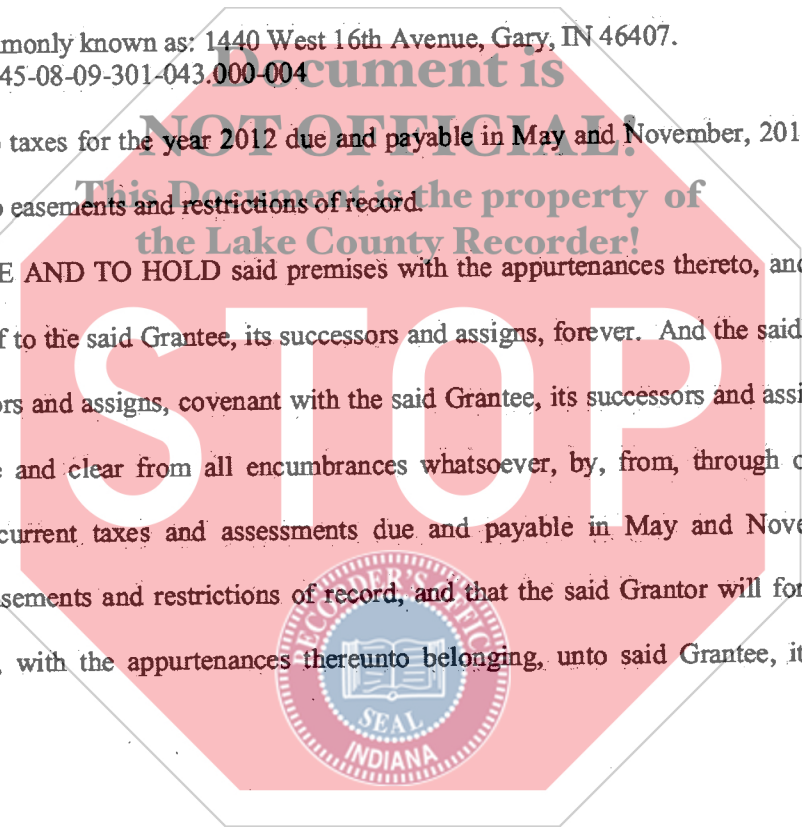

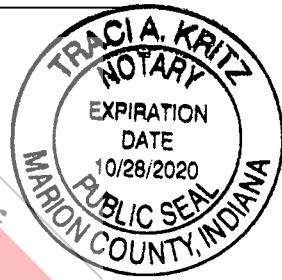
