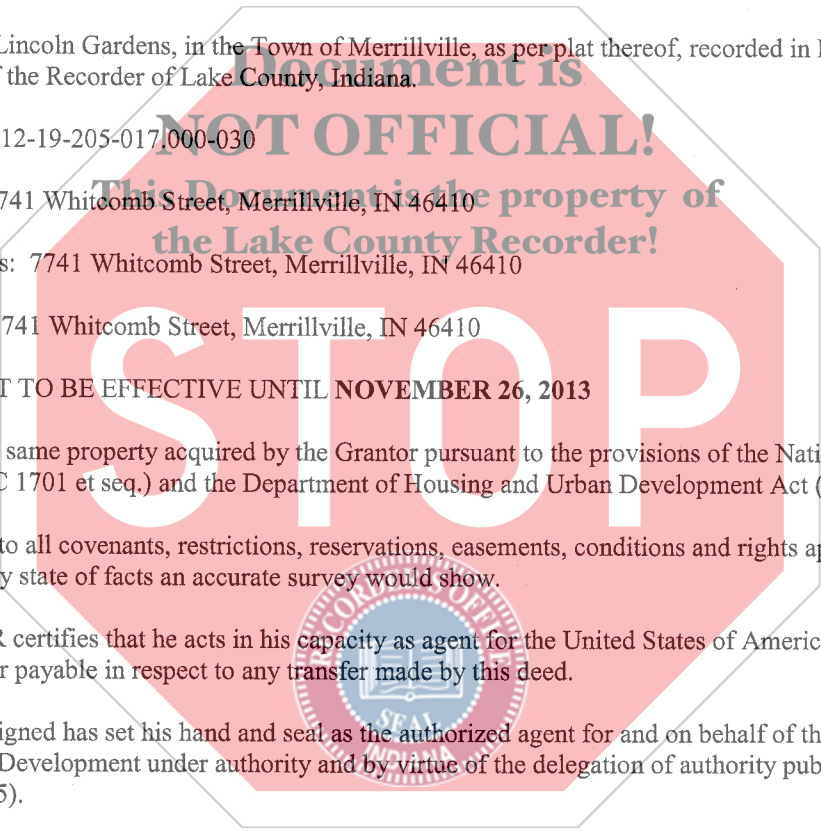
THIS DEED IS NOT TO BE EFFECTIVE UNTIL NOVEMBER 26, 2013
