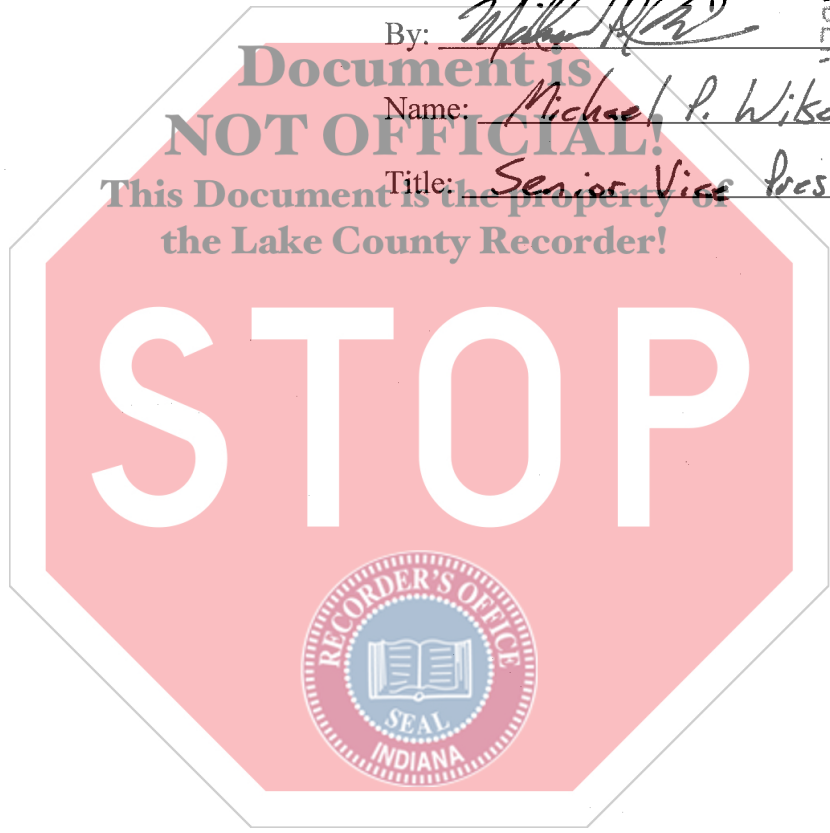

EXHIBIT A

Legal Description

Part of Lots 5 through 10, both inclusive; all of Lots 11 through 16, both inclusive; all of Lots 19 through 28, both inclusive; part of Lot "B" and part of the vacated North-South alley adjacent to said Lots, all in Block 1, Standard Addition to the City of Whiting, Indiana as shown in Plat Book 6 page 29, in the Office of the Recorder of Lake County, Indiana, being more particularly described as follows: Commencing at the Southwest corner of Lot "B" in said Block 1, Standard Addition to Whiting; thence North 0° 00' East, along the West line of said Lot "B" (also being the East line of Oliver Street), a distance of 304.3 feet to the place of beginning; thence North 90° 00' East, at right angles to the West line of said Lot "B", a distance of 117.0 feet; thence South 85° 54' 02" East, a distance of 60.15 feet to a point lying within Lot 5 in said Block 1, Standard Addition, which is 60.0 feet East and 4.3 feet South of the last described point; thence North 90° 00' East, a distance of 20.35 feet, more or less, to a point lying 105.0 feet West of the East line of Lots 1 through 16 in said Block 1, Standard Addition. (Also being the West line of New York Avenue); thence Northerly, along a line parallel with and 105.0 feet West of the East line of said Lots 1 through 16, a distance of 213.0 feet, more or less, to a point on the South line of Lot 11 in said Block 1, Standard Addition; thence Easterly, along the South line of said Lot 11, a distance of 105.0 feet to the Southeast corner of said Lot 11; thence Northerly, along the East line of Lots 11 through 16 in said Block 1, Standard Addition, a distance of 212.2 feet to the point of intersection of the West line of New York Avenue and the Southwesterly line of Ohio Avenue; thence Northwesterly, along the Southwesterly line of Ohio Avenue, a distance of 42.21 feet to the Northeasterly corner of Lot 16 in said Block 1, Standard Addition; thence Westerly, along the North line of Lots 16 and 19 in said Block 1, a distance of 268.89 feet to the Northwest corner of Lot 19 in said Block 1; thence South 0° 00' West, along the West line of Lots 19 through 28 and the West line of Lot "B" in said Block 1, a distance of 448.7 feet to the place of beginning, except the East 75 feet of the North 9 inches of Lot 19, all in Whiting, Lake County, Indiana.
