

GENERAL DURABLE POWER OF ATTORNEY

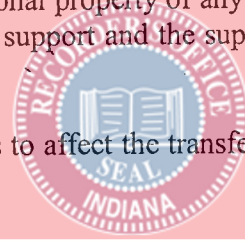
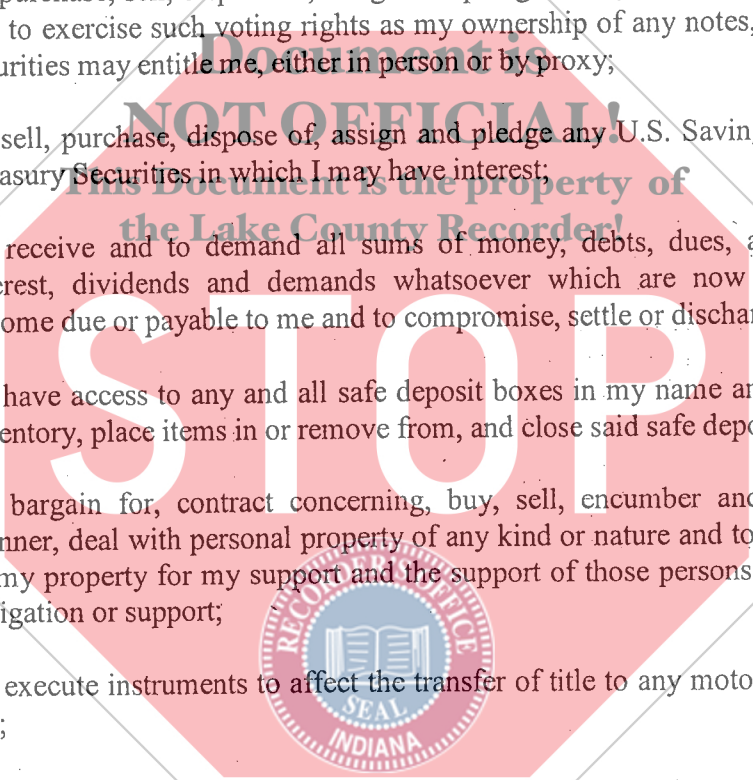
I, FLORENCE CROSS, of LAKE COUNTY, State of INDIANA, being at least eighteen (18) years of age and mentally competent, do hereby designate V. BELIN TUCKER-CROSS of LAKE COUNTY, State of INDIANA, as my true and lawful Attorney-in-Fact.

The above-named Attorney-in-Fact shall have the following powers:

1. To make, draw and indorse promissory notes and checks for any and all checking and or savings accounts and/or any and all other financial or stock accounts, or bills of exchange and to waive demand, presentment, protest, notice of protest, and notice of non-payment of all such instruments, and to take any and all other actions to manage any and all checking and/or savings accounts and/or any and all other financial or stock accounts, including but not limited to adding, deleting, modifying and/or changing in any way the names in which any such account(s) is/are held at any financial institution;
2. To make and execute any and all contracts;
3. To purchase, sell, dispose of, assign and pledge notes, stocks, bonds and securities, and to exercise such voting rights as my ownership of any notes, stocks, bonds and securities may entitle me, either in person or by proxy;
4. To sell, purchase, dispose of, assign and pledge any U.S. Savings Bonds and U.S. Treasury Securities in which I may have interest;
5. To receive and to demand all sums of money, debts, dues, accounts, bequests, interest, dividends and demands whatsoever which are now or hereafter become due or payable to me and to compromise, settle or discharge the same;
6. To have access to any and all safe deposit boxes in my name and to open, inspect, inventory, place items in or remove from, and close said safe deposit boxes;
7. To bargain for, contract concerning, buy, sell, encumber and in any way and manner, deal with personal property of any kind or nature and to apply or make use of my property for my support and the support of those persons to whom I owe an obligation or support;
8. To execute instruments to affect the transfer of title to any motor vehicle owned by me;
9. To maintain, purchase, surrender, acquire, assign, pledge, make claims under, borrow against, partially or fully liquidate, change beneficiaries, designate insureds, and generally deal in all forms of insurance, to include medical, and claims thereon;
10. To purchase, sell, mortgage, convey and lease any interest in real estate, wherever located, of which I may be owner now or hereafter.
