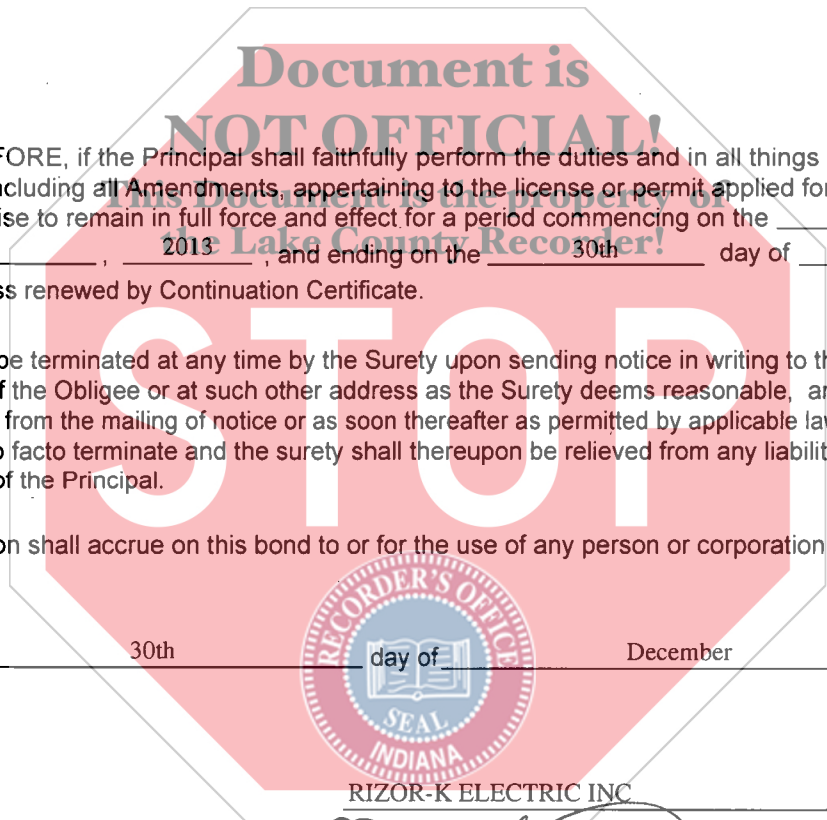

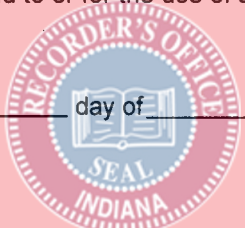


NOW THEREFORE, if the Principal shall faithfully perform the duties and in all things comply with the laws

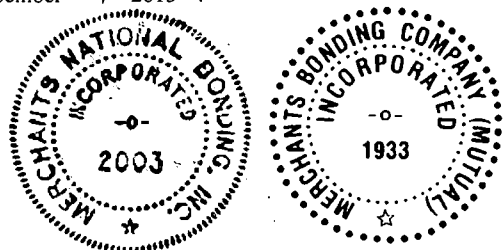
