SPECIAL WARRANTY DEED

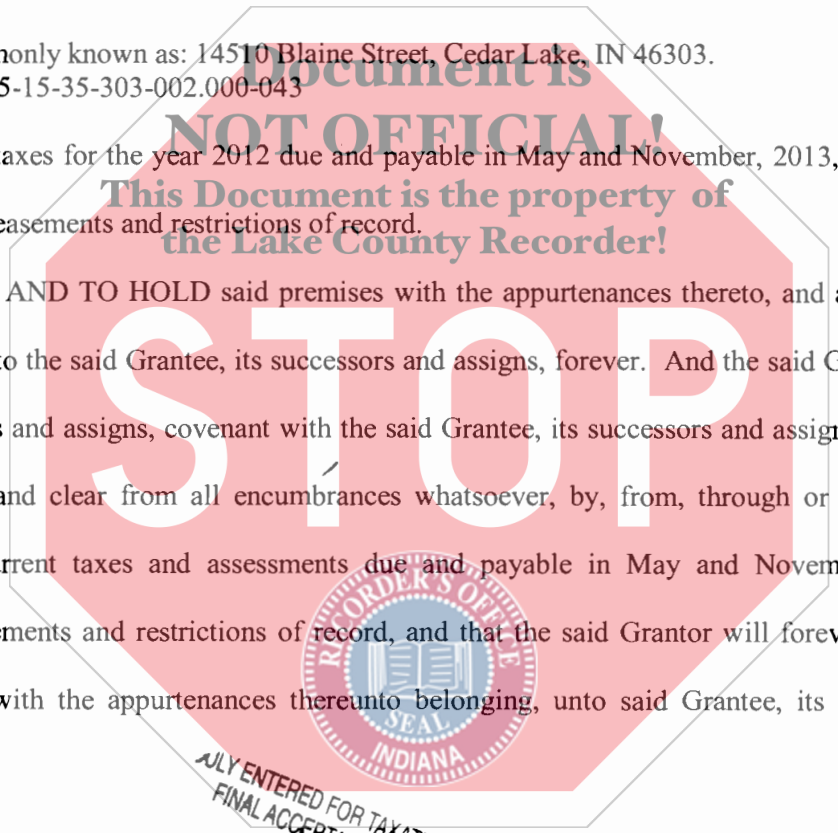



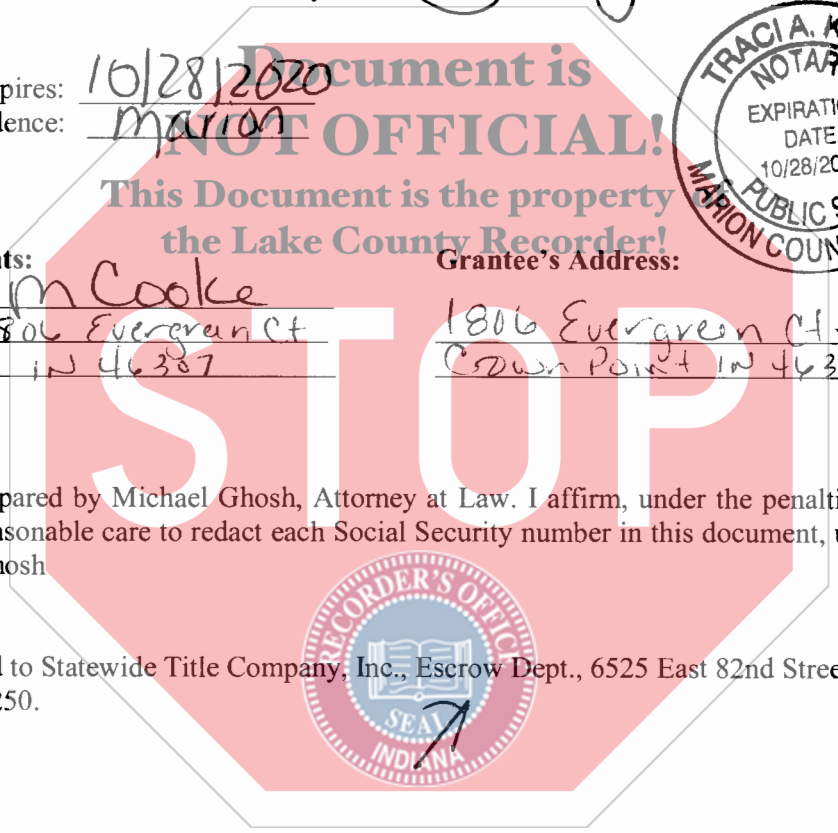
