Mission Statement: **BAAR INTERNATIONALTRUST** is a Tax Exempt Aboriginal Tribal 501 (d) Trust Unincorporated Association and foundation Founded on (02-20-2012) and by these articles in the Aboriginal Region (Wasat) which primary objective is to: The primary objective of **BAAR INTERNATIONALTRUST** is to function as a multi-purpose Aboriginal Tribal Ecclesiastical/Religious Association Trust that operates all property of Beneficiary Barbara Jeanette Andrews.

All Articles of this religious association are incorporated as the foundational articles of this Aboriginal Tribal Trust including all additional amendments.

Any other amendments to these articles can only be made by a properly delegated fiduciary in Trust for the CEO Minister (Ba'Ara El Ali) by the specific authorization by the CEO as expressed in contract with authentication from the CEO Minister (Ba'Ara El Ali) for the Benefit of the Beneficiary Barbara Jeanette Andrews.
