This obligation may be canceled by the Surety by giving thirty (30) days notice in writing of its intention to do so to the Obligees, and the Surety shall be relieved of any further liability under this bond thirty (30) days after receipt of said notice by the Obligees, except for defaults occurring prior thereto.

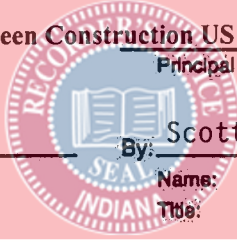

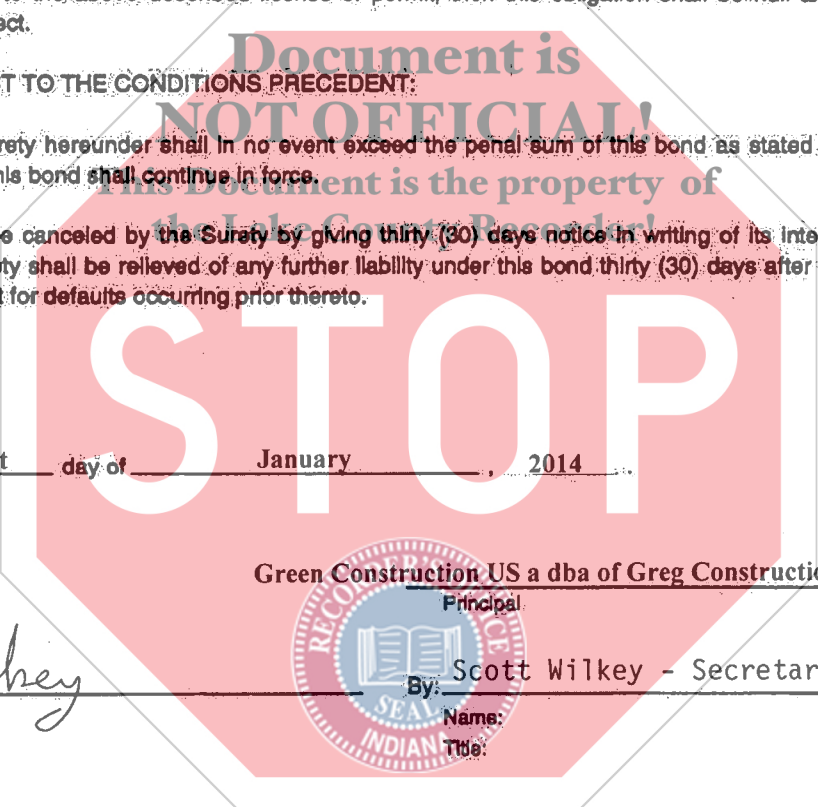

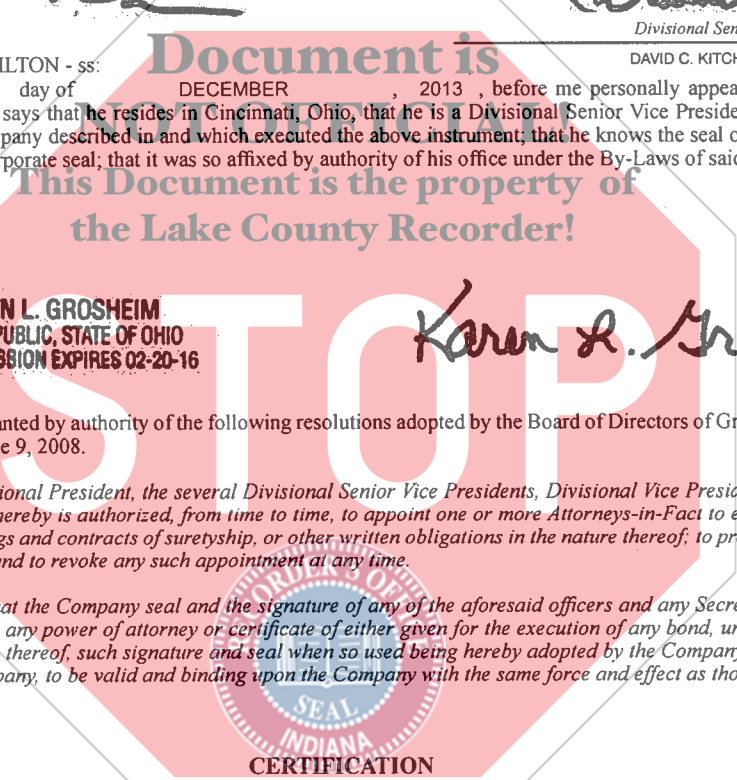
