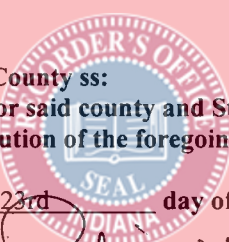
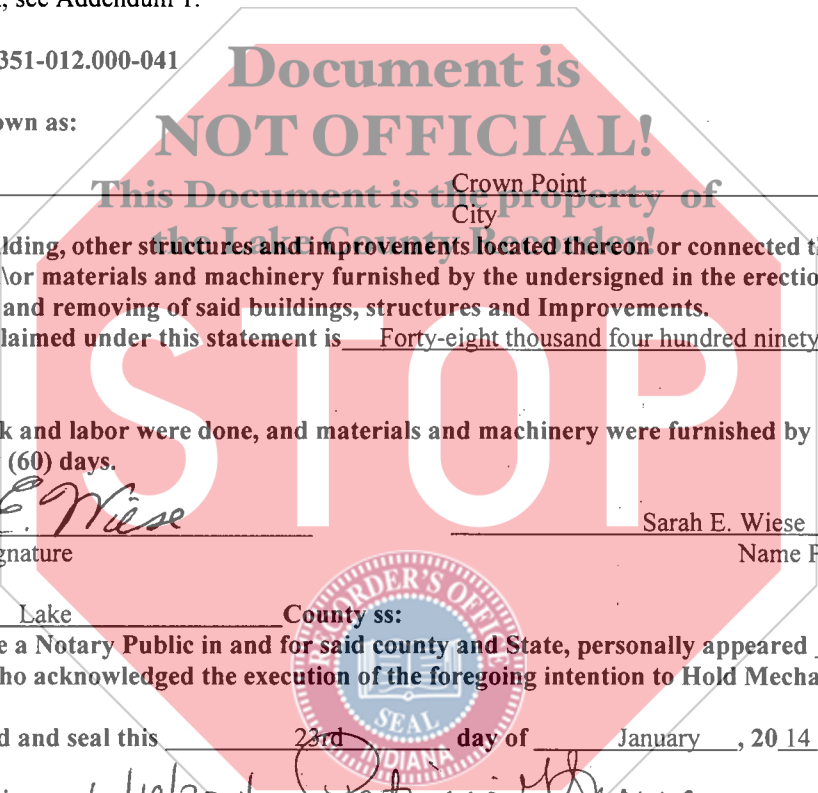

ADDENDUM 1
