**AGREED JUDGMENT**

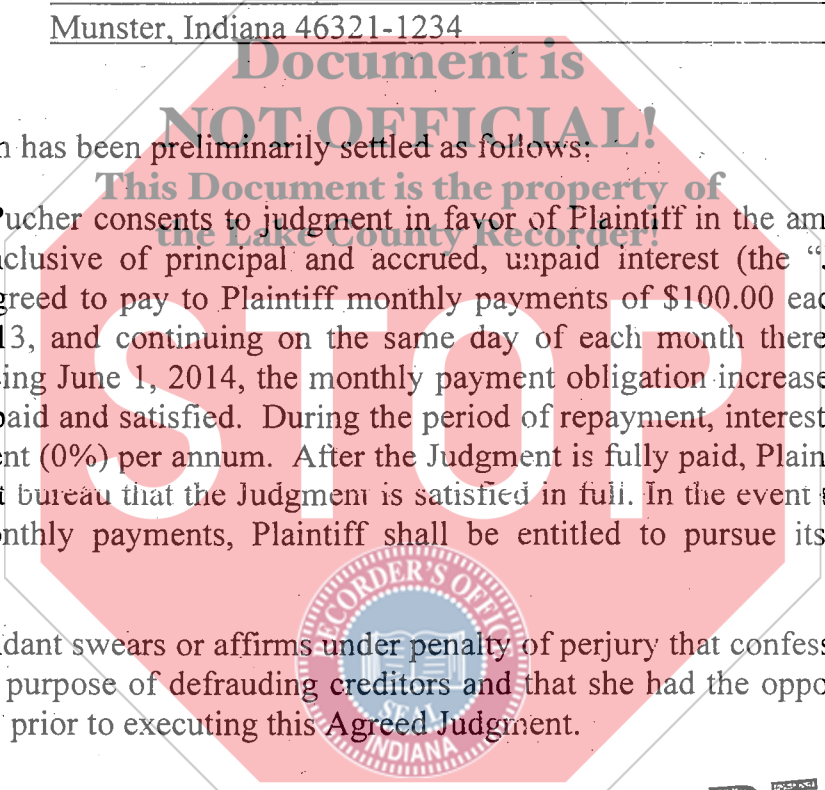

This action has been preliminarily settled as follows:

Rebecca Pucher consents to judgment in favor of Plaintiff in the amount of \$6,941.40, which sum is inclusive of principal and accrued, unpaid interest (the "Judgment"). Said Defendant has agreed to pay to Plaintiff monthly payments of \$100.00 each commencing on December 1, 2013, and continuing on the same day of each month thereafter until May 2014. Commencing June 1, 2014, the monthly payment obligation increases to \$215.00, until the Judgment is paid and satisfied. During the period of repayment, interest shall accrue at the rate of zero percent (0%) per annum. After the Judgment is fully paid, Plaintiff shall notify the appropriate credit bureau that the Judgment is satisfied in full. In the event the Defendant fails to make her monthly payments, Plaintiff shall be entitled to pursue its rights under this Judgment.

The Defendant swears or affirms under penalty of perjury that confession of judgment is not made for the purpose of defrauding creditors and that she had the opportunity to seek the advice of counsel prior to executing this Agreed Judgment.
