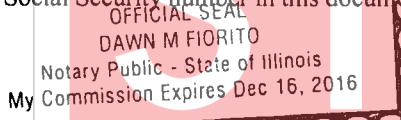

Matthew Mcgee was a patient hospitalized on 01/10/14-01/11/14 due to an injury that occurred on 01/08/14. The total charges due for hospital care, treatment, or maintenance during the above hospitalization(s) is \$13,316.58, subject to all credits for payments, contractual adjustments, write offs and any other benefit in favor of the patient. The lien is reduced from total charges to limit the patient's financial obligation under the terms of any public or private benefits to which the patient is entitled.
