- A. Pursuant to the terms of that "Grant of Building Facilities Easement" dated December 30, 1997 and recorded January 5, 1998 in the Land Records of Lake County, Indiana as Instrument Number 98000967 (the "Easement"), State Line conveyed to ComEd certain easement rights to install, maintain and access equipment on the "Burdened Parcel" (as defined in the Easement, and as legally described on Exhibit A hereto). - B. The parties executed the Easement, in part, to effectuate the purposes and intent of an unrecorded "Facilities Agreement" dated December 30, 1997 by and among, State Line, ComEd and Commonwealth Edison Company (the "Facilities Agreement").
- C. The Facilities Agreement has been terminated, and State Line intends to discontinue use of, and may in fact dismantle, the buildings and related structures that have heretofore been encumbered by the Easement.
- D. Recognizing that the Easement no longer serves the interests of the parties, the parties hereby desire to terminate the Easement.

NOW THEREFORE, in consideration of the premises, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. <u>Easement Terminated</u>. As of the Effective Date, and except as otherwise provided herein, the Easement is hereby terminated and shall have no further force or effect and shall no longer be deemed to be an encumbrance on the Burdened Parcel.
- 2. <u>Survival of Indemnities</u>. State Line and ComEd agree that the Grantor Indemnitiees (as described in Section 9 of the Easement) and all the provisions related thereto shall survive this Termination for any and all damages, losses, liabilities, costs and expenses incurred prior to the Effective Date. Likewise, State Line and ComEd agree that the Grantee Indemnitees (as described in Section 10 of the Easement) and all the provisions related thereto shall survive this Termination for any and all damages, losses, liabilities, costs and expenses incurred prior to the Effective Date.
- 3. Other Rights Not Affected. The parties recognize that ComEd is the beneficiary of other recorded easements that burden the Burdened Parcel, and nothing herein shall be deemed to limit or otherwise affect ComEd's rights under those recorded easement agreements.
