2. That my husband, David M. Harvey, died on October 27, 2013, leaving me, Donald L. Harvey, as his widow, never having filed for or having been divorced.

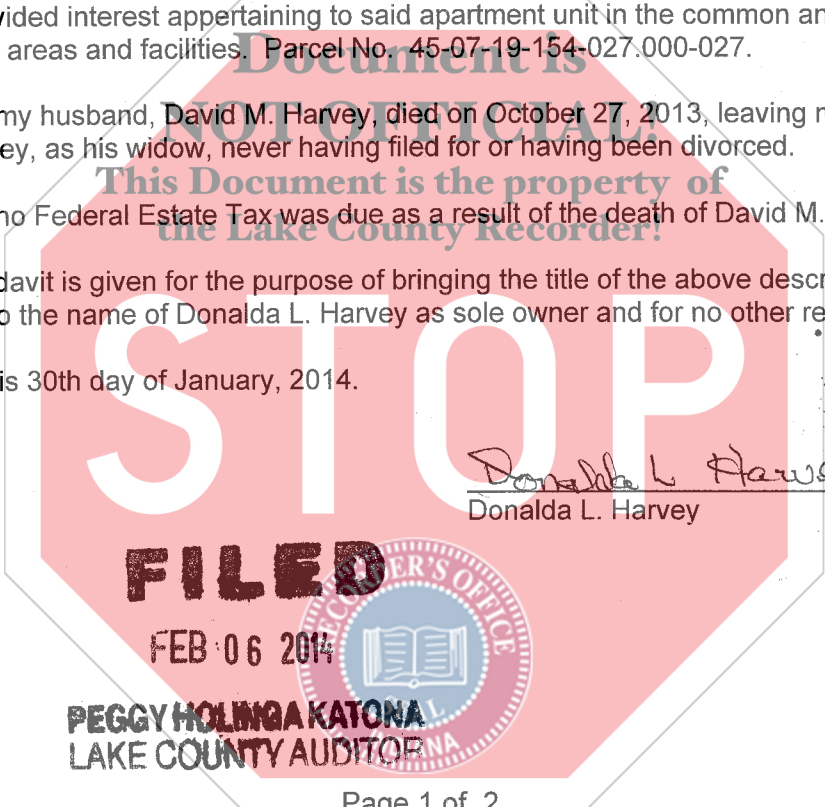
3. That no Federal Estate Tax was due as a result of the death of David M. Harvey.
