The Grantee shall have the right of access to the real estate described above, and the right at any time, and as frequently as necessary, to clear and remove any and all timber, brush, debris and other obstructions of any kind located upon said real estate which, in the sole judgment of the Grantee, should be removed to prevent interference with the said storm sewer line, structures, devices or facilities of the Grantee. The Grantor shall not erect nor cause to be erected any structure, building or appurtenance upon the easement area. The Grantee shall be responsible for and shall compensate the Grantor for any damage to fences, crops, or other property of the Grantors, caused either by the original construction of said lines, equipment, devices or facilities, or by any subsequent activities on behalf of Grantee in connection with such sewage and drainage lines, structures, devices or facilities.
