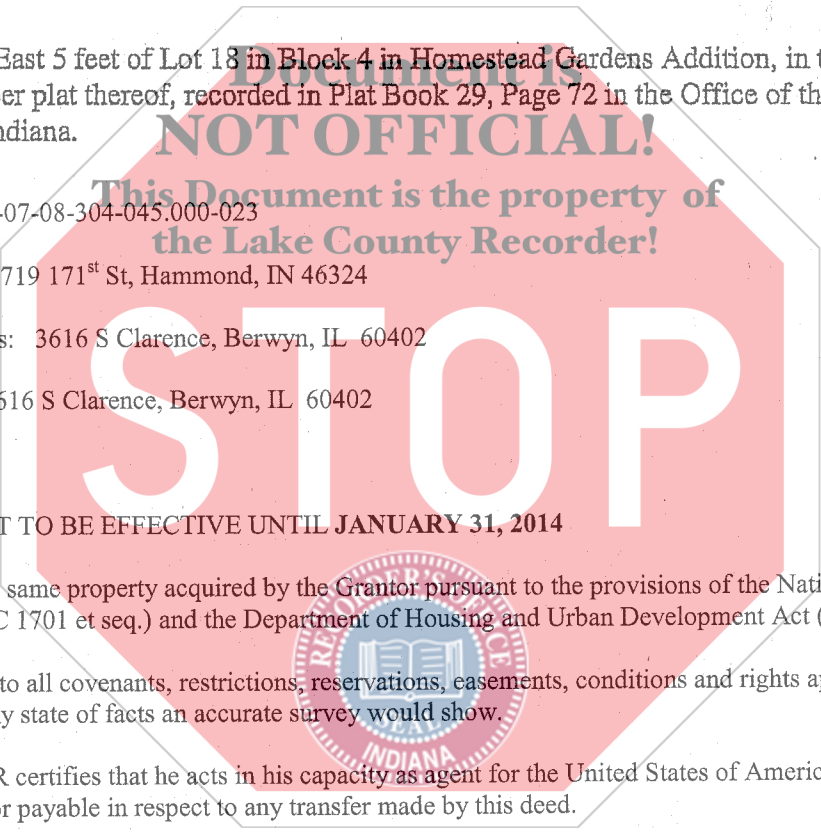
THIS DEED IS NOT TO BE EFFECTIVE UNTIL JANUARY 31, 2014

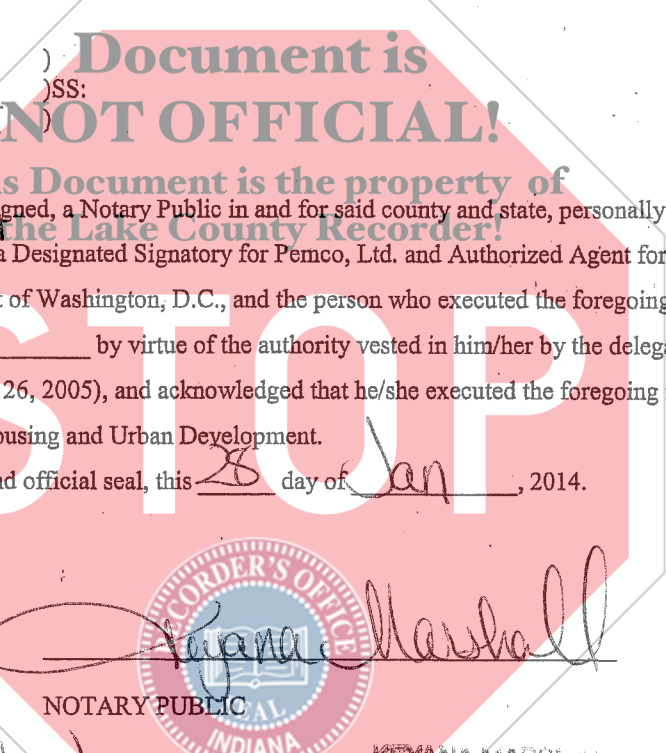
