In accordance with Title 865, 1-12-1 through 1-12-30 of the Indiana Administrative Code, the following observations and opinions are submitted regarding the various uncertainties in the locations of the lines and corners established on this survey as a result of:

(a) Reference monuments of record. (b) Title documents of record.

(c) Evidence of active lines of occupation

(d) Relative positional Accuracy "RPA". This Retracement Survey was performed at the Request of the owners of the property to divide into parcels as directed by the owners to facilitate the division and sale of portions of the estate. REFERENCE SURVEYS:

3. Copy of plat of Hoffman's Addition to Crown Point MONUMENT AVAILABILITY:

Iron rods were found with Krull cap at the corners of the above captioned survey in good condition. Iron pipe were found marking corners along the Northerly line of the survey parcel. Iron pipes were found Northwesterly of the parcel along Joliet Street at various parcel corners. The monuments found were in good condition. THEORY OF LOCATION:

A traverse was run between the found monumentation along with back of walks and curbs and other improvements found along the survey parcel. The resultant survey was rotated to match the angle/ bearing in the Deeds. The resultant distances were close to many of the deed calls. There were no original corners found along the frontage of Joliet Street. The existing walk line seems to fit fairly close to the deed calls. The deed description was fit to the iron pipes found along the Northerly line of the parcel and the resutant figure fit the walk line and didtances to momuments found along Joilet Street. The descriptions written on the palt are based on this boundary. POSSESSION LINES:

There is fencing along the Northerly line of the parcels which is running at a slightly differnt angle than the survey. The fence is about on line at the Northeast corner of Parcel 1; the fence is 0.5' South of the N.W. corner of Parcel 1; the fence is 1.8' South of the N.W. corner of Parcel 2. The existing drive way is not within the existing ingress/egress easement. A driveway at the Southeast corner of Parcel 4 encroached on Parcel 4 by a foot or so. That drive has obviously been in that location for some time. There is no other visible sign of occupation along the lines. DESCRIPTIONS:

Upon examination of the adjoining deeds no gaps or overlaps were discovered. New descriptions were written as directed to facilitate Quit Claims among parties to create the new parcels.




