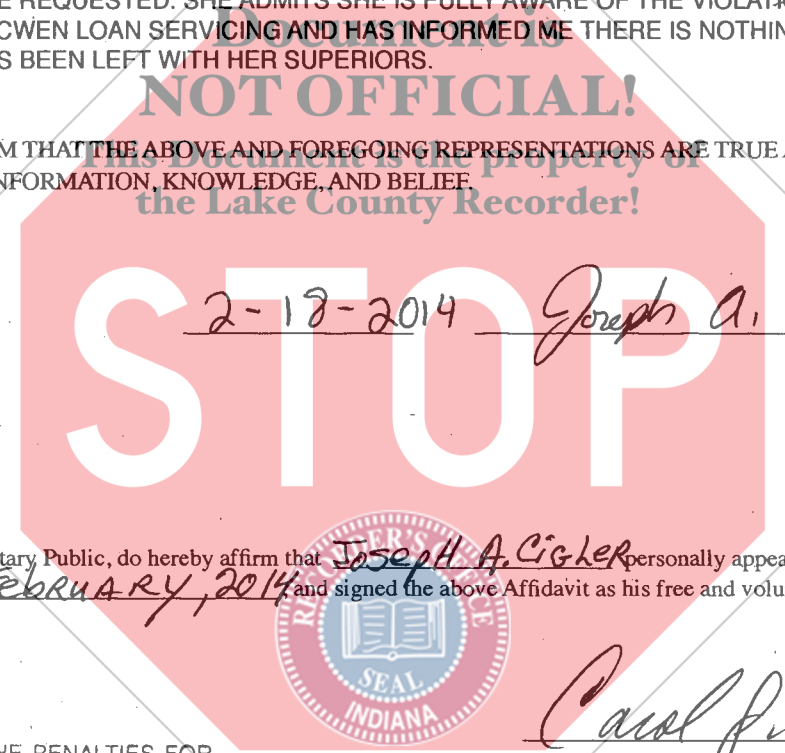

I, JOSEPH AARON CIGLER DUE SWEAR OR AFFIRM:

I BELIEVE THAT FRAUD HAS BEEN INVOLVED IN THE OBTAINING AND ONGOING SERVICING OF THE MORTGAGE I PURPORTEDLY ENTERED INTO WITH THE PETITIONER. FRAUD INVALIDATES ALL CONTRACTS. OCWEN EMPLOYEE KATHERINE AT EXTENSION 45168 HAS NOT SENT ME THE INFORMATION I REQUESTED. KATHERINE ADMITTED TO ME VIA PHONE CALL THAT SHE KNEW THE LAW, THAT SHE HAS 15 DAYS TO GET ME THE INFORMATION REQUESTED. SHE IS ALSO WELL AWARE THEY ARE ALREADY IN VIOLATION OF THE FOIA ACT SINCE MY ORIGINAL REQUEST WAS ON THE 20TH OF JANUARY, 2014. BEFORE FILING THIS AFFIDAVIT, OCWEN EMPLOYEE KATHERINE AT EXTENSION 45168, ON MONDAY DAY 17 OF FEBRUARY, 2014, TOLD ME THAT SHE IS UNABLE TO GET THE POLICY I HAVE REQUESTED. SHE ADMITS SHE IS FULLY AWARE OF THE VIOLATION OF THE LAW COMMITTED BY OCWEN LOAN SERVICING AND HAS INFORMED ME THERE IS NOTHING SHE CAN DO, THE REQUEST HAS BEEN LEFT WITH HER SUPERIORS.
