

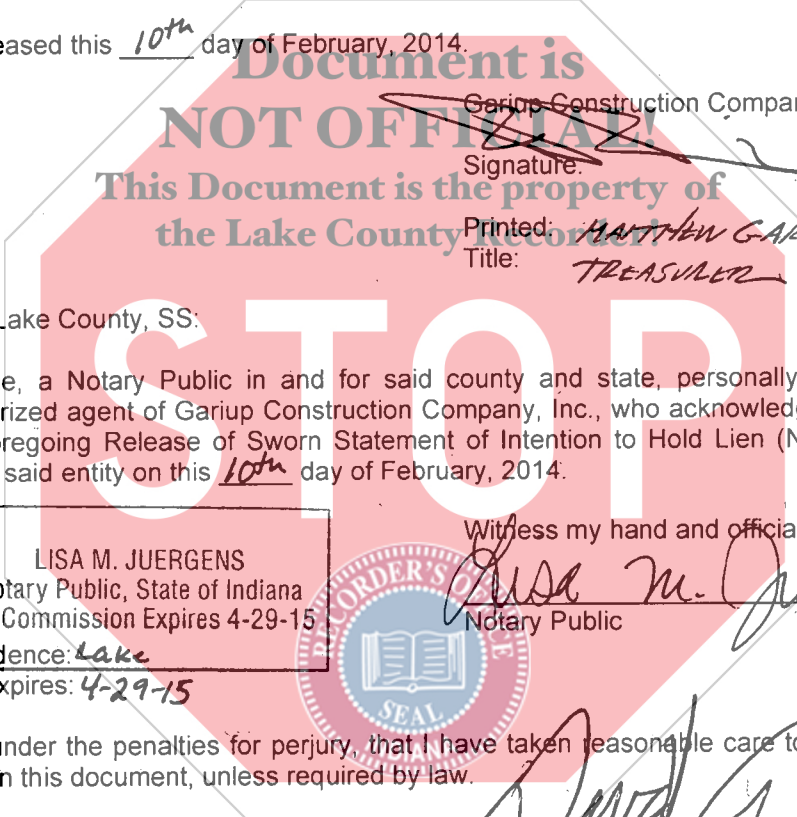
**RELEASE OF
