SPECIAL WARRANTY DEED

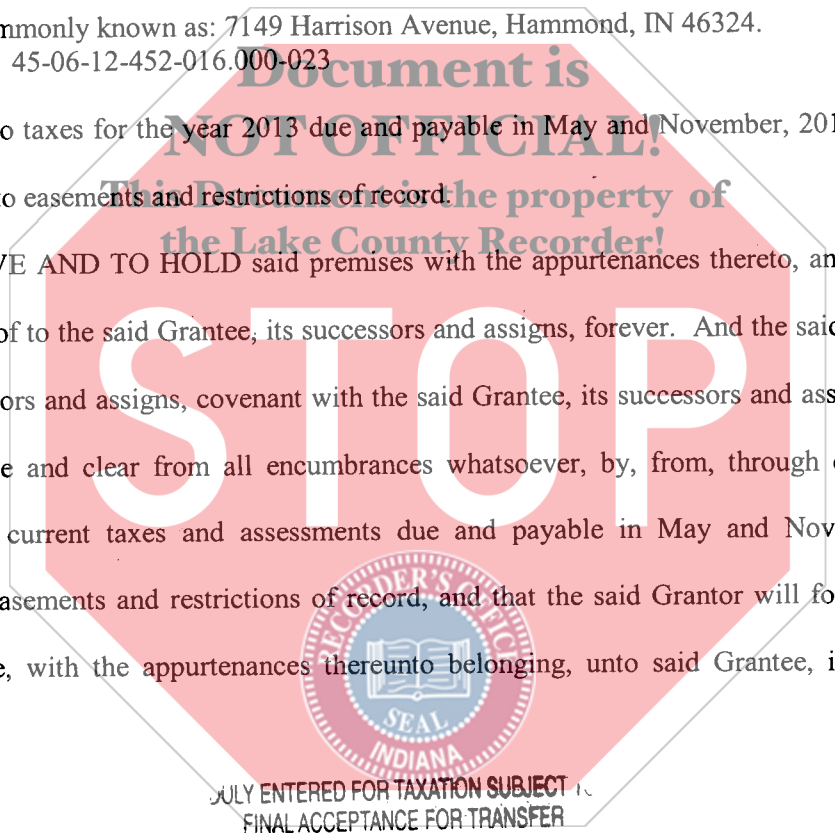

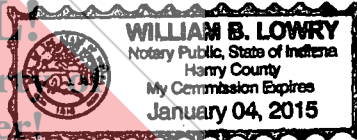
