SPECIAL WARRANTY DEED

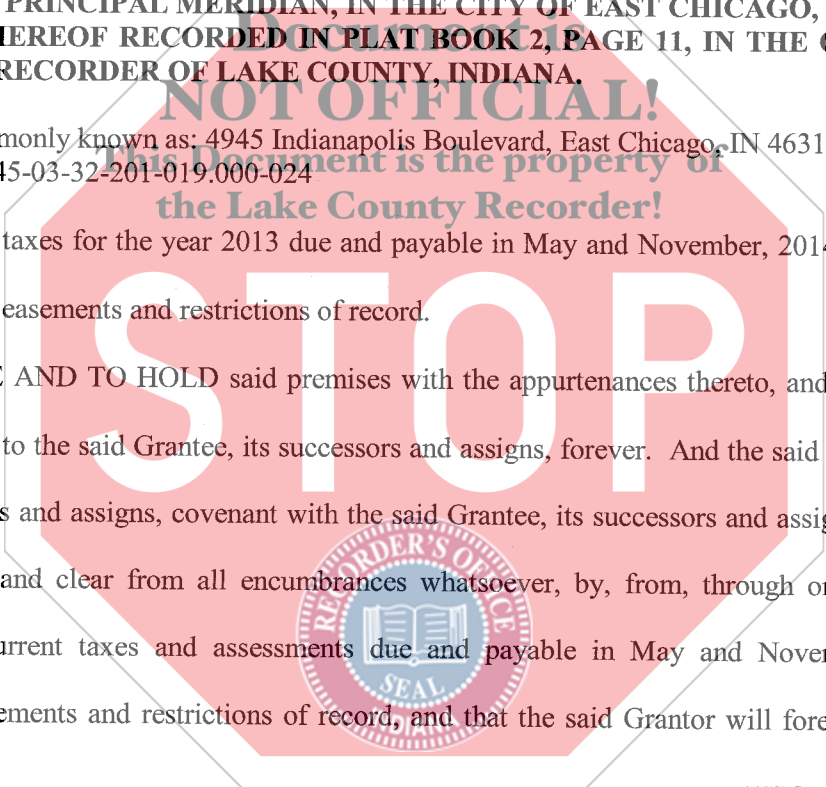

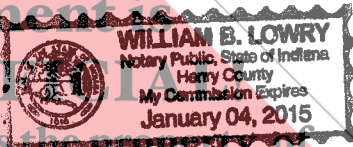
