PURSUANT TO I.C. 29-3.5-4-1**

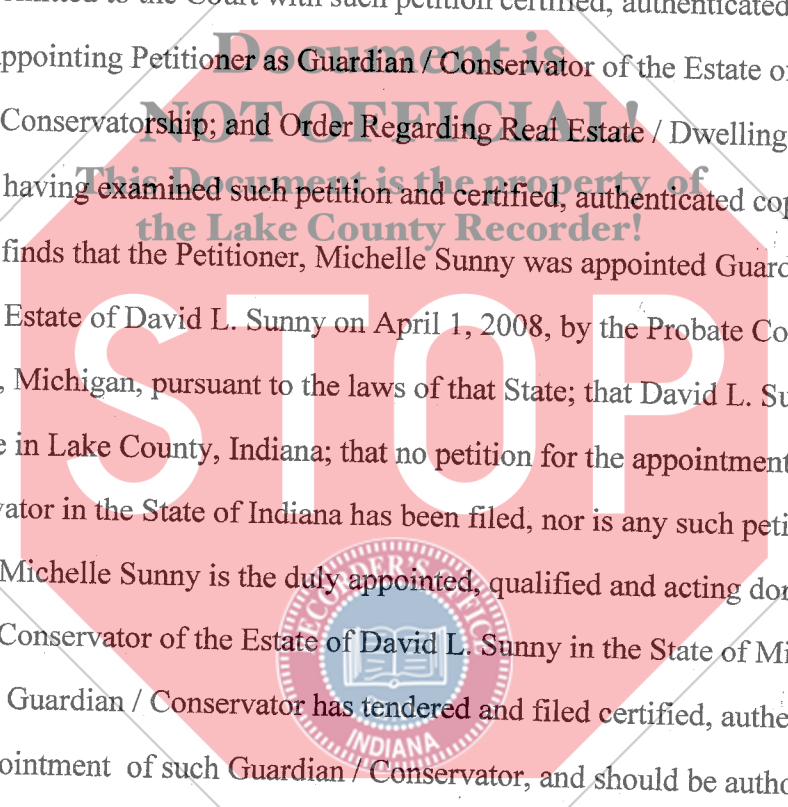

This matter comes before the Court upon the Petition by Domiciliary Foreign Guardian / Conservator To Register Evidence Of Appointment Pursuant to I.C. 29-3.5-4-1.

There is submitted to the Court with such petition certified, authenticated copies of the following: Order appointing Petitioner as Guardian / Conservator of the Estate of David L. Sunny; Letters of Conservatorship; and Order Regarding Real Estate / Dwelling.
