LICENSE OR PERMIT BOND



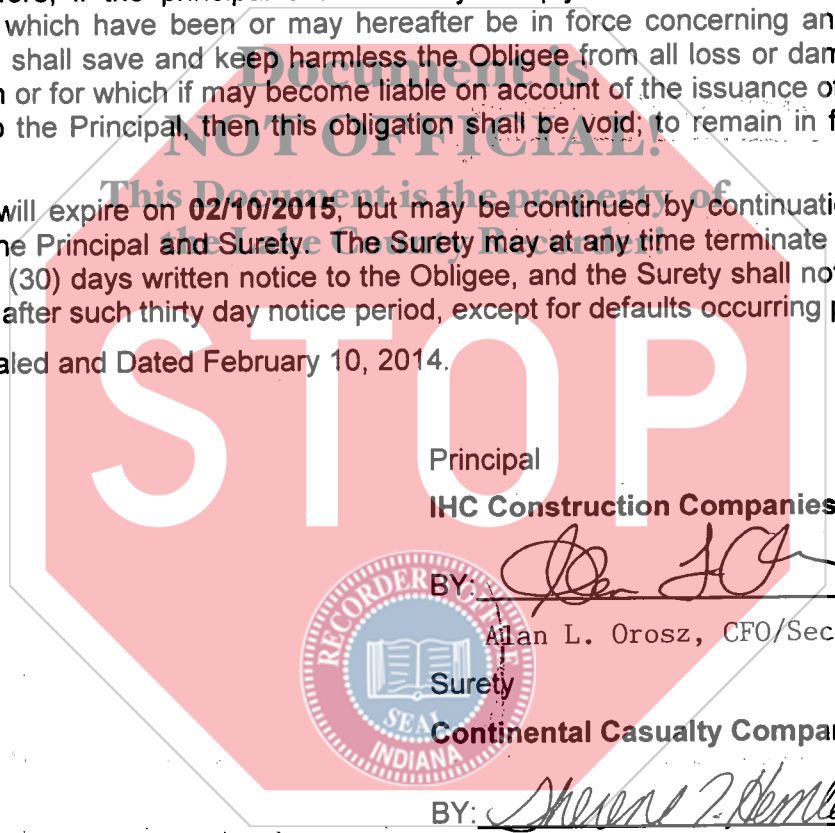
