THERE MAY BE UNWRITTEN RIGHTS ASSOCIATED WITH THESE UNCERTAINTIES. THE NORTHWEST; NORTH QUARTER; CENTER; WEST QUARTER; SOUTH QUARTER; AND SOUTHWEST CORNERS OF THIS SECTION HAVE BEEN RECOVERED AS PERPETUATED BY THE LAKE COUNTY SURVEYOR'S OFFICE. ALSO RECOVERED WERE POINTS SURROUNDING THE "PETERSON" TRACT NEAR THE WEST QUARTER CORNER OF THE SECTION. FROM THE LOCATION OF THESE CORNERS, AS WELL AS, THE ORIGINAL GOVERNMENT NOTES, DUE TO THIS SECTION BEING FRACTIONAL, THIS SECTION WAS BROKEN DOWN TO DETERMINE THE NORTHWEST QUARTER AND DIVISION THEREOF.
