The State of Indiana appears by Deputy Prosecuting Attorney Michael Haynes. The defendant appears in person, in custody, with Deputy Public Defender Robert Varga. Michelle Manoski reporting. The parties file a Stipulated Plea and Agreement whereby the defendant tenders a plea of guilty to Count I, Check Fraud, a Class D felony. A factual basis is established for the plea, and the Court finds the defendant's plea of guilty to be knowing and voluntarily made. Judgment of conviction is entered on Count I, Check Fraud, a Class D felony. The parties waive the presentence investigation report and wish to proceed to sentencing today. According to the agreed term in the plea agreement, the defendant is sentenced to six (6) months in the Indiana Department of Correction. The defendant is to receive credit for eighty-nine (89) days spent in confinement as a result of this charge, plus eighty-nine (89) days of good time credit as provided by law, for a total of one hundred seventy-eight (178) days credit.

A judgment is entered against the defendant in the amount of four hundred twenty-seven dollars and ninety-eight cents (\$427.98). The defendant is ordered to pay restitution in this amount. The clerk is ordered to forward restitution to Tru Value Store, 7120 West 133rd Avenue, Cedar Lake, IN 46303.

The defendant having been found to be indigent, court costs are ordered entered of record. The clerk is directed to prepare an electronic abstract of judgment and to notify the Sheriff of Lake County. Cause disposed.
