CONTRACT FOR CONDITIONAL SALE OF REAL ESTATE

THIS CONTRACT, made and entered into by and between ROBERT NOWAK, (hereinafter called "Seller") and ELISEO HARO and MARIA M. BENITEZ (hereinafter called "Buyers"). Each of the above individuals being over eighteen (18) years of age.

WITNESSETH:

Seller hereby agrees to and does sell to Buyer, and Buyer hereby agrees to and does purchase from Seller, the following described real estate (including any improvement or improvements now or hereafter located on it) in Lake County, Indiana, (such real estate, including improvements, being hereinafter called the "Real Estate") upon the following covenants, terms and conditions:

THE SOUTH 20 FEET OF THE NORTH 436 FEET OF BLOCK 7 IN PARK PLACE ADDITION TO THE TOWN OF HIGHLAND, INDIANA, AS PER PLAT THEREOF RECORDED IN THE OFFICE OF THE RECORDER OF LAKE COUNTY, INDIANA.

SECTION 1. THE PURCHASE PRICE AND MANNER OF PAYMENT.

1.01 THE PURCHASE PRICE. As the purchase price for the Real Estate, Buyer agrees to pay to Seller and Seller agrees to accept from Buyer the sum of NINETY THOUSAND DOLLARS (\$90,000.00).

1.02 THE MANNER OF PAYMENT. The purchase price shall be paid in the following manner:

(a) The sum of FIVE THOUSAND DOLLARS (\$5,000.00) is immediately due upon the execution and delivery of this Contract, the receipt of such sum is hereby acknowledged by Seller. Seller acknowledges that a part of this payment is to represent a prepayment of the first month's installment payment for taking possession of the Real Estate. In the event that Buyer defaults under this contract and fails to take possession of the Real Estate, then the parties agree that the Seller shall retain the entire \$5,000.00 as liquidated damages.

(b) The sum of FIFTEEN THOUSAND DOLLARS (\$15,000.00) shall be due upon delivery of possession of the Real Estate on September 1, 2013, (Possession Date) leaving an unpaid balance of the purchase price in the sum of SEVENTY THOUSAND DOLLARS (\$70,000.00). That amount, as it is reduced by payments and expenses of Buyer properly credited under this Contract, and as it is increased by payments and expenses of Seller properly made and incurred under this Contract, is hereinafter called the "Unpaid Purchase Price".

(c) The Unpaid Purchase Price shall bear interest at the rate of SIX PERCENT (6.0%) per annum. Interest at such rate shall begin to accrue from the Date of Possession, or from the date payments made and costs and expenses incurred by Seller are added to the Unpaid Purchase Price pursuant to this Contract, as may be applicable.

(d) The Unpaid Purchase Price and interest on it shall be paid in monthly installments in the amount of NINE HUNDRED AND NINETEEN DOLLARS AND NINETY CENTS (\$919.90), beginning October 1, 2013. Subsequent installments shall be paid on the same day of each month thereafter until August 1, 2021, at which time the Unpaid Purchase Price, with accrued but unpaid interest, shall be paid in full.

(f) Buyer shall have a grace period of FIVE (5) days from the due date of any installment required under this Contract within which to pay such installment. If such installment is not actually received by Seller within the grace period, then a late charge in a sum equal to TWENTY FIVE DOLLARS (25.00) shall accrue and be immediately due and payable. Should Buyer incur two consecutive late charges during the term of this contract or altogether fail to make an installment payment, then Buyer shall be considered to be in material breach of this Contract, whereby Seller shall be entitled to seek any and all relief granted to him under the terms of this Contract.

(h) Each installment received by Seller shall be applied: first to accrued late charge, then to interest accrued to the due date of such installment, and then to the reduction of the Unpaid Purchase Price.

(i) Each payment under this contract shall be sent to Seller at the following address: 5672 Kingman, Portage, IN 46368, or such other address as Seller shall designate in writing.

SECTION 2. PREPAYMENT OF PURCHASE PRICE.

2.01 Buyer shall have the privilege of paying without penalty, at any time, any sum or sums in addition to the payments herein required. It is agreed that no such prepayments, except payment in full, shall stop the accrual of interest on the amounts so paid until the next succeeding computation of interest after such payment is made. Interest shall not accrue after the date on which Buyer makes any payment that constitutes full payment of the Unpaid Purchase Price.

SECTION 3. TAXES, ASSESSMENTS, INSURANCE, AND UTILITIES.

3.01 TAXES. The real estates taxes on said Real Estate are \$2,319.04 per year or \$193.25 per month, plus an additional \$45.00 per year for a special assessment for the Little Calumet River Basin Levee project. Buyer agrees to assume and pay the taxes on the Real Estate beginning with the first or spring installment due and payable on or before May 10, 2015, together with all installments of real estate taxes due and payable thereafter. The Seller is responsible for all of the 2012 real estate taxes that are due and payable in the year 2013 and Seller further agrees to pay the real estate taxes for the year 2013, but prorated up to the Date of Possession, September 15, 2013. Thus, Seller shall pay the first installment of the 2013 taxes, which are due and payable on or before May 10, 2014, while the Buyer and Seller will be jointly responsible for paying the second installment of the 2013 real estate taxes that are due and payable on or before November 12, 2014, with each parties' share being prorated up to the Date of Possession of September 15, 2013. If either party fails to satisfy his respective tax payment responsibility as stated herein, then the other party shall have the right to pay the real estate taxes on the other's behalf, as stated in Section 3.05 below. Buyer, upon written notice to Seller, and at Buyer's sole expense, may contest on behalf of the parties any changes in the assessed value of the Real Estate. At all times during this Contract, the parties will present to the other within seven (7) days of receipt thereof, a copy of the real estate tax bill statements and any special assessments, if any, and shall further provide proof of payment thereof. The real estate taxes are NOT included as part of Buyer's monthly installment payment for the purchase of the Real Estate.

3.02. ASSESSMENTS. Buyer agrees to pay any assessments or charges upon or applying to the Real Estate for public or municipal improvements or services which, after the date of this Contract, are assessed or charged to the Real Estate. Buyer is also responsible for any homeowner's association assessments payments, if any. Any additional assessments or charges upon said Real Estate are NOT included as part of Buyer's monthly contract installment payment.

3.03. PENALTIES. The parties hereto agree to pay any penalties, whether in the form of interest or otherwise, in connection with the late or untimely payment of such taxes, assessments or charges, for which they are responsible, as stated under Section 3.01.

3.04. INSURANCE. At all times during the period of this Contract, Seller shall:

(a) Keep the improvements located upon the Real Estate insured under fire and extended coverage policies in an amount not less than the Unpaid Purchase Price, and

(b) Keep Flood Hazard Insurance on the Real Estate in the amount of the Unpaid Purchase Price or the highest amount available if less than the Unpaid Purchase Price if; the Real Estate is located in a Flood Hazard Zone as shown by a current certificate of survey according to the maps in the office of the County Surveyor, unless such insurance coverage is waived in writing by the Seller, and

(c) Keep standard liability insurance with coverage in amounts not less than One Hundred Thousand Dollars (\$100,000.00) per person and Three Hundred Thousand Dollars (\$300,000.00) per occurrence, and

(d) Buyer shall be responsible for payment of all such premiums which are currently in the amount of \$100.00 per month. Buyer's responsibility for payment on such insurance is NOT part of his monthly contract installment.

Except as otherwise agreed hereafter in writing, Buyer shall not enter into the settlement of any insurance claim covered under the foregoing insurance policies without the written consent of Seller. Any insurance proceeds received as payment for any loss of, or damage to the Real Estate covered by said insurance, shall be applied to the restoration and repair of the loss or damage. All restoration and repairs shall be performed in accordance with all state and local building codes and shall meet the quality of the improvements pre-existing any loss or damage and all work shall be performed by a duly licensed contractor. Notwithstanding the above provisions, if there exists an uncured Event of Default by Buyer under this Contract on the date of receipt of such proceeds, the proceeds may be applied, at Seller's option toward pre-payment of the Unpaid Purchase Price, with any excess to be paid to Buyer.

3.05. UTILITIES. At all times during the period of this Contract:

(a) Buyer shall be responsible for all utilities, including but not limited to gas, electric, water, garbage, phone, cable, dish satellite, and internet and Buyer shall maintain the accounts for the same in his name. At all times during the term of this Contract, Buyer is to maintain service of all utilities on said Real Estate Buyer and shall not disconnect or temporarily interrupt such services. Buyer shall show documentation to Seller that all such accounts are listed in Buyer's name within three (3) days of the Date of Possession. Buyer shall also execute an authorization form that allows Seller to have access to all utility account information to allow Seller to determine if the respective accounts are delinquent or current.

(b) In the event that Seller discovers that any utility account is delinquent for more than one billing period or that a particular utility service has been temporarily or permanently disconnected, then such delinquency or disconnection shall be considered to be a material breach of this Contract, whereby Seller shall the right to exercise any and all remedies available to him under this Contract.

3.05. RIGHTS OF PARTIES TO PERFORM OTHER'S COVENANTS.

(a) If one of the parties hereto (hereinafter called "Responsible Party") fails to perform any act or to make any payment required by this Section 3, the other party (hereinafter called "Nonresponsible Party") shall have the right at any time and without notice, to perform any such act or to make any such payment, and in exercising such right, to incur necessary and incidental costs and expenses, including attorney fees. Nothing in this provision shall imply any obligation on the part of the Nonresponsible Party to perform any act or to make any payment required of the responsible Party under the terms of this Contract.

(b) The exercise of such right by a Nonresponsible Party shall not constitute a release of any obligation of the responsible Party under this Section 3 or a waiver of any remedy available under this Contract, nor shall such exercise constitute an estoppel to the exercise by a Nonresponsible Party of any right or remedy of his or a subsequent failure by the Responsible Party to perform any act or make any payment required by him under this Section 3.

(c) Payments made and all costs and expenses incurred by a Nonresponsible Party in connection with the exercise of such right shall, at his option, either (i) be paid to him by the Responsible Party within thirty (20) days after written demand therefore; or (ii) on the date the next installment payment is due under this Contract, following written notice, be added to the Unpaid Purchase Price, if Buyer is the Responsible Party, or applied to reduce the Unpaid Purchase Price, if Seller is the Responsible Party.

(d) In the event a Nonresponsible Party makes any such payments or incurs any such costs and expenses, the amount thereof shall bear interest at the rate provided under Section 1 of this Contract, from the respective dates of making the same, until paid in full, or to the date such amounts are added to, or applied against, the Unpaid Purchase Price.

(e) In the event that Buyer fails to reimburse Seller for all costs and expenses incurred for his failure to make any payment as required in this Contract, Seller may declare the Contract in material default and exercise any and all remedies available to him herein.

3.06. CONDEMNATION. From the date hereof, Buyer shall assume all risk of loss or damage by reason of condemnation or taking of all or any part of the Real Estate for public or quasi-public purposes, and no such taking shall constitute a failure of consideration or cause for rescission of this Contract by Buyer. Should all or any part of the Real Estate be condemned and sold by court order, or sold under the threat of condemnation to any public or quasi-public body, the net amount received for the damage portion shall be retained by Buyer, and net amount received for the Real Estate value shall be paid to Seller and applied as a reduction of the Unpaid Purchase Price. The authority and responsibility for negotiation, settlement, or suit shall be Buyer's. If Buyer incurs expenses for appraisers, attorneys, accountants or other professional advisers, whether with or without suit, such expenses and any other applicable costs shall be deducted from the total proceeds to calculate the "net amount" and shall be allocated proportionately between the amount determined as damages and the amount determined for value of the Real Estate. If no determination is made of separate amounts for damages and Real Estate value, then the net amount shall be divided equally between Buyer and Seller, with Seller's amount to be applied as a reduction of the Unpaid Purchase Price.

SECTION 4. POSSESSION.

4.01. DELIVERY OF POSSESSION. Seller shall deliver to Buyer full and complete possession of the Real Estate on or before September 1, 2013. Buyer's right of possession shall continue until terminated pursuant to Section 9. All utilities shall be paid by Seller up to the date possession.

SECTION 5. EVIDENCE OF TITLE. (If title evidence is furnished herewith, strike Subsection 5.02)

5.01. If Buyer is not in default under this Contract, Seller will furnish Buyer:

An Owner's title insurance policy disclosing marketable title to the Real Estate to a date which is the earlier of (a) a date after execution of this Contract specified by Buyer in a notice to Seller or (b) a date 30 days prior to the date the final payment under this Contract is due. (Strike the one that is inapplicable)

5.02. TITLE INSURANCE. A title insurance policy furnished under this Contract shall be in the amount of the purchase price and shall be issued by an insurer satisfactory to Seller.

5.03. ADDITIONAL TITLE EVIDENCE. Any additional title evidence shall be at the expense of Buyer, provided, however, that the cost of additional title evidence necessitated by the acts or omissions of Seller shall be borne by Seller.

5.04. CONVEYANCE OF TITLE Seller covenants and agrees that upon the payment of all sums due under this Contract and the prompt and full performance by Buyer of all covenants and agreements herein made, Seller will convey or cause to be conveyed to Buyer, by Quit Claim Deed, the above described Real Estate, provided all taxes and assessments which are Buyer's obligations are current.

SECTION 6. SELLER'S RIGHT TO MORTGAGE THE REAL ESTATE.

6.01. MORTGAGE LOAN. Without Buyer's consent and without obligation to Buyer except as set forth in this Section 6, Seller shall have the right to retain, renew, extend or renegotiate a loan or loans secured by mortgage(s) on the Real Estate (all instruments

evidencing a loan(s) and a mortgage(s) securing it is hereinafter called "Loan"), provided that the terms of each loan do not conflict with the provisions of Section 6 or any other provision of this Contract and do not exceed current loan balance. Seller shall pay each loan when due.

6.02. PROVISION OF LOAN. Each Loan made by Seller shall:

(a) be in such principal amount that the aggregate principal balance of all Loans shall not exceed the Unpaid Purchase Price for the Real Estate;

(b) have total periodic payments which do not exceed the periodic payments by Buyer under this Contract, and shall provide for the regular amortization rate of the principal of Seller's Loan which exceeds the amortization rate of the Unpaid Purchase Price of this Contract;

(c) provide for prepayment in full at Seller's option, whether with or without premium, at any time.

6.03. NOTICE OF LOAN. Contemporaneously with the execution of a Loan, Seller shall give Buyer written notice and inform Buyer in reasonable detail of the principal amount of the Loan, the name and address of the mortgagee, the installments payable under the Loan, and such other terms as Buyer may reasonably request.

6.04. DEFAULT OF LOAN. In the event of Seller's default of a Loan, Buyer shall have the right, on behalf of Seller, to make loan payments or to cure other defaults. Seller shall, upon written demand of Buyer, pay to Buyer the amount of any such payments and the costs incurred by Buyer incurring other default (including in such costs Buyer's attorney fees) plus interest at the rate under this Contract, interest on such amount or costs being computed from the date of payment or incurring of such costs until paid. Buyer shall have the option to deduct the amount of such payments, costs, and interest from payments payable under this Contract.

6.05. RELEASES. Upon payment in full by Buyer of all amounts payable under this Contract, Seller shall pay in full all amounts payable under Loan(s) at the time outstanding and obtain and record, or cause to be recorded, a valid release of Loan(s) so paid.

6.06. ENCUMBRANCE. Seller represents that the Real Estate is encumbered with a Loan. If encumbered, Seller represents that the information regarding said Loan is as follows:

(a) Name of lender: EVERBANK (Florida)

(b) Unpaid balance of Loan: \$6,500.00.

SECTION 7. ASSIGNMENT OF CONTRACT, SALE OF INTEREST IN REAL ESTATE, RENTAL OF INTEREST.

7.01. Buyer's interest in this Contract cannot be sold or assigned to any family member or to a third party and the Buyer cannot lease any part of his interest or any improvements located on or within the Real Estate to any family member or third party.

SECTION 8. USE OF THE REAL ESTATE BY BUYER; SELLER'S RIGHT TO INSPECTION.

8.01. USE. The Real Estate (may) (may not) be leased or occupied by persons other than Buyer and Buyer's children.

8.02. IMPROVEMENTS. Buyer may materially alter, change, or remove any improvements now or hereafter located on the Real Estate, or make any additional improvements, only with prior written consent of Seller, which consent shall not be unreasonably withheld. Buyer shall have the right to paint the interior of the Real Estate without the firsthand permission of the Seller. Seller will be solely responsible for the maintenance and repairs of the structure, roof, plumbing, heating, air conditioning and water heater, unless it can be shown that a repair was necessitated by the acts or negligence of the Buyer, his family, or his guests. Buyer shall not create, or allow any mechanics, laborers, material men, or other creditors of Buyer or an assignee of Buyer to obtain, a lien or attachment against Seller's interest herein and Buyer agrees that he is solely responsible for all costs and attorneys fees that Seller may have to incur to remove such liens or to prevent attachments. Buyer agrees that the Real Estate and any improvements thereon are, as of the date of this Contract, in good condition, order, and repair, and Buyer shall, at his own expense maintain the Real Estate and any improvements in as good order and repair as they are in on the date of this Contract, ordinary wear and tear, and acts of God or any public authorities excepted. Buyer shall not commit waste on the Real Estate, and, with respect to occupancy and use, shall comply with all laws, ordinances and regulations of any governmental authority having jurisdiction thereof.

8.03. INSPECTION. Seller shall have the right to enter and inspect the Real Estate at any reasonable time provided at least 24 hours written notice is provided to Buyer. The 24 hour time period may be waived in the case of an emergency. Seller shall not have the right to inspect the property more than four times per calendar year unless the inspection is related to a repair or a materially improvement performed on the Real Estate.

8.04. BUYER'S RESPONSIBILITY FOR ACCIDENTS. Buyer assumes all risk and responsibility for injury or damage to person or property arising from Buyer's use and control of the Real Estate and any improvements thereon.

8.05. ENVIRONMENTAL REPRESENTATIONS, WARRANTIES, AND COVENANTS OF PARTIES. The Parties make the following representations, warranties, and covenants:

(a) Seller warrants and represents to the best of his knowledge, there do not currently exist, and Buyer warrants, represents, and covenants there will not exist during the term of this Contract, any actual or potential contamination of the soil, subsoil, groundwater, or any other portion of the Real Estate by any hazardous or toxic substance or their constituents, or any underground tanks on the Real Estate (other than for the use of heating oil for use and consumption of Buyer on the Real Estate).

(b) Seller warrants and represents to the best of his knowledge, Seller and Seller's predecessors in title have complied at all times with all applicable federal, state, and local environmental laws and regulations including, without limitation, the Indiana Responsible Property Transfer Law ("IRPTL") (I.C. 13-25-3) as amended, the Comprehensive Environmental Response, Compensation and Liability Act of 1980 (42 U.S.C. Section 9601, et seq.), as amended, the Resource Conservation and Recovery Act of 1976 (42 U.S.C. Section 6901, et seq.) as amended, the Toxic Substances Control Act (15 U.S.C. Section 2601, et seq.) as amended, and all regulations under them, and any other federal statute and any state statute and any state statute and any municipal ordinance creating liability for treatment, storage, disposal, arranging, or existence on the Real Estate of any hazardous or toxic substance, including their constituents. ("Environmental Laws")

(c) Buyer covenants to comply at all times during the term of this Contract with all Environmental Laws.

(d) Seller warrants and represents to the best of Seller's knowledge, no environment filings have been made concerning the Real Estate with any governmental agency.

(e) Each of the parties indemnifies the other against, and holds the other harmless from, any claim, action, loss, damage, liability, cost, or expenses (including attorney fees and all reasonable environmental testing expenses such party incurs as a result of the other party's breach of any representation, warranty, or covenants made in this Section 8.05).

8.06. INDEMNIFICATION. In addition to the provision of Section 8.05, Buyer agrees to indemnify and save harmless Seller from and against any an all claims, liability, damage, costs or expense which Seller may incur, including reasonable attorney fees, by reason of the Buyer's use or occupancy of the Real Estate, or arising out of any act of the Buyer, Buyer's agents, licensees and invitees.

SECTION 9. BUYER'S DEFAULT AND SELLER'S REMEDIES.

9.01. TIME. Time is of the essence of this Contract.

9.02. BUYER'S DEFAULT. Upon the occurrence of any Event of Default, as hereinafter defined, Seller shall have the right to pursue immediately any remedy available under this Contract as may be necessary or appropriate to protect Seller's interest under this Contract and in the Real Estate.

9.03. EVENT OF DEFAULT. The following shall each constitute an Event of Default for purposes of this Contract:

- (a) Failure by Buyer for a period of ten (10) days [not less than five (5) days] to pay any payments required to be made by Buyer to Seller under this Contract when and as it becomes due and payable.
- (b) Lease or encumbrance of the Real Estate or any part thereof by Buyer, other than as expressly permitted by this Contract.
- (c) Causing or permitting by Buyer of the making of any levy, seizure or attachment of the Real Estate or any part thereof.
- (d) Occurrence of an uninsured loss with respect to the Real Estate or any part thereof.
- (e) Institution of insolvency proceedings against Buyer, or the adjustment, liquidation, extension or composition or arrangement of debts of Buyer or for any other relief under any insolvency law relating to the relief of debtors; or, Buyer's assignment for the benefit of creditors or admission in writing of his inability to pay his debts as they become due; or, administration by a receiver or similar officer of any of the Real Estate.
- (f) Desertion or abandonment by Buyer of any portion of the Real Estate.
- (g) Actual or threatened alteration, demolition, waste or removal of any improvement now or hereafter located on the Real Estate, except as permitted by this Contract.
- (h) Failure by Buyer, for a period of seven (7) days after written notice is given to Buyer, to perform or observe any other covenant or term of this Contract.

9.04. SELLER'S REMEDIES. Upon the occurrence of an Event of Default, Seller shall elect his remedy under Subsection 9.041 or 9.042 (unless Subsection 9.043 is applicable).

9.0-41. Selier may declare this Contract forfeited and terminated, and upon such declaration, all right, title and interest of Buyer in and to the Real Estate shall immediately cease and Buyer shall then be considered as a tenant holding over without permission and Seller shall be entitled to re-enter and take immediate possession of the Real Estate and to eject Buyer and all persons claiming under him. Further, Seller shall have the right to institute legal action to have this Contract forfeited and terminated and to recover from Buyer all or any of the following:

- (a) possession of the Real Estate;
- (b) any payment due and unpaid at the time of filing of the action and becoming due and unpaid from that time until possession of the Real Estate is recovered;
- (c) interest on the Unpaid Purchase Price from the last date to which interest was paid until judgment or possession is recovered by Seller, whichever shall occur first; provided, however, that this shall not be construed as allowing Seller to recover any interest which would be included under Subsection 9.041 (b) above;
- (d) due and unpaid real estate taxes, assessments, charges and penalties which Buyer is obligated to pay under this Contract;
- (e) premiums due and unpaid for insurance which Buyer is obligated to provide under this Contract;
- (f) the reasonable cost of repair of any physical damage or waste to the Real Estate other than damage caused by ordinary wear and tear and acts of God or public authorities; and
- (g) any other amounts which Buyer is obligated to pay under this Contract.

9.042. Seller may declare all of the sums secured by this Contract to be immediately due and payable, and Seller may institute legal action to recover same. When all of such sums are paid to Seller, Seller shall convey or cause to be conveyed to Buyer, by Warranty Deed, the Real Estate subject to restrictions and easements of record as of the date of this Contract and all taxes and assessments which are Buyer's obligation.

9.043. In the event Buyer has substantial equity in the Real Estate when an Event of Default occurs, then this Contract shall be considered the same as a promissory note secured by a real estate mortgage, and Seller's remedy shall be that of foreclosure in the same manner that real estate mortgages are foreclosed under Indiana law and Seller may not avail himself of the remedies set forth in Subsection 9.041 or 9.042. If this Subsection 9.043 is applicable, then Seller may declare all of the sums secured by this Contract to be immediately due and payable, and Seller may immediately institute legal action to foreclose this Contract and Buyer's interest in the Real Estate. The parties agree that after Buyer has paid \$40,000.00 of the purchase price (which price means the original purchase price set forth in Subsection 1.01), then Buyer shall have substantial equity in the Real Estate.

9.05. SELLER'S ADDITIONAL REMEDIES. In addition to the remedies set forth above, upon the occurrence of an Event of Default, Seller shall be entitled to:

- (a) Retain (without prejudice to his right to recover any other sums from Buyer, or to have any other remedy under this Contract), as an agreed payment for Buyer's use of the Real Estate prior to the Event of Default, all payments made by Buyer to Seller and all sums received by Seller in the form of down payments, earnest monies, advances and/or proceeds of insurance or other benefits or considerations pursuant to this Contract.
- (b) Request that a receiver be appointed over the Real Estate in accordance with Indiana law providing for real estate mortgage foreclosures.
- (c) Enforce any right without relief from valuation or appraisal laws.

SECTION 10. SELLER'S DEFAULT AND BUYER'S REMEDIES.

10.01. If Seller fails to convey the Real Estate as required by this Contract, Buyer may institute legal action against Seller for specific performance in which case Seller hereby acknowledges that an adequate remedy for default in such case does not exist at law; or Buyer may pursue such other remedy as is available at law or in equity.

10.02. If, after seven (7) days notice from Buyer, Seller fails to make any payment required of him under this Contract or to perform or observe any other of his covenants or agreements Buyer shall be entitled to institute legal action against Seller for such relief as may be available at law or in equity. Nothing in this subsection shall interfere with or affect Buyer's right to any reduction, set-off or credit to which Buyer may be entitled in the event of Seller's failure to pay amounts required of him pursuant to this Contract.

SECTION 11. GENERAL AGREEMENTS.

11.01. This Contract shall bind, and inure to the benefit of, the parties and their heirs, personal and legal representatives, and successors, and shall be interpreted under the laws of the State of Indiana.

11.02. If Seller or Buyer consists of more than one person, each person signing this Contract as Seller or Buyer shall be jointly and severally bound to the terms and conditions of this Contract.

11.03. Headings are for reference only, and do not affect the provisions of this Contract. Where appropriate, the masculine gender shall include the feminine or the neuter, and the singular shall include the plural.

11.04. A memorandum of this Contract shall be recorded and shall be of the same force and effect as though the entire instrument had been recorded. Said recording being necessary for Buyer to receive the various real estate tax exemptions offered by the county.

11.05. Each party is entitled to recover his reasonable attorney fees, costs, and expenses incurred by reason of enforcing his rights hereunder, including the expenses of preparing any notice of delinquency, whether or not any legal action is instituted.

11.06. The failure or omission of either party to enforce any of his right or remedies upon any breach of any of the covenants, terms or conditions of this Contract shall not bar or abridge any of his rights or remedies upon any subsequent default.

11.07. Any notices to be given hereunder shall be in writing and deemed sufficiently given when (1) served on the person to be notified, or (2) placed in an envelope directed to the person to be notified at his last known address and deposited in a United States Post Office mail box, postage prepaid.

11.08. In computing a time period prescribed in this Contract, the day of the act or event shall not be counted. All subsequent days, including intervening weekend days and holidays, shall be counted in the period.

SECTION 12. ADDITIONAL COVENANTS. Buyers are purchasing the property "AS-IS" and their signatures below represent that understanding.

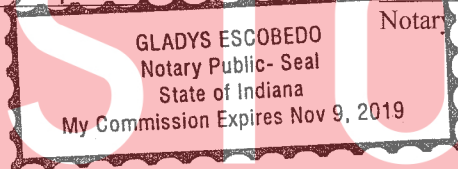

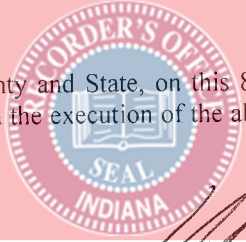

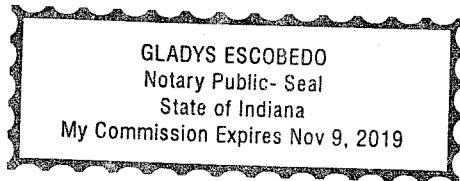
