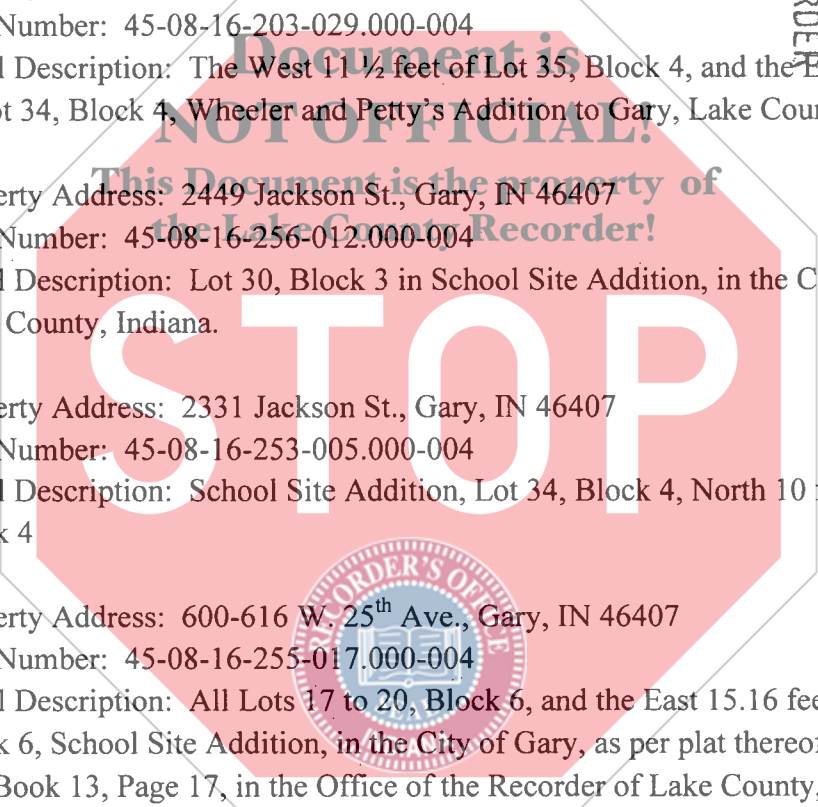

This transfer is made in pursuant to IC 6-1.1-24-6.7 and in accordance with the Order of the Board of Commissioners entered at a Special Meeting at which there was a public hearing held on April 23, 2014. The terms and conditions of the transfer are that the LAKE COUNTY PROPERTY DEVELOPMENT CORPORATION will subsequently transfer title to this property to the CITY OF GARY, which shall begin rehabilitating the property for the benefit of low income residents within six (6) months of this transfer. If the Lake County Property Development Corporation fails to convey the property to the City of Gary within thirty (30) days, the title to the property shall revert to the former owner. Since the property is being conveyed without extinguishing current substantial property interests other than the County waiving all delinquent taxes, special assessments, penalties, interests, and costs, the CITY OF GARY will have to file within six (6) months a quiet title action to extinguish the title in the current property owner and the interest of any other party who has a substantial interest in the property.

Subject to all liens, encumbrances, easements, taxes and restrictions of record.


