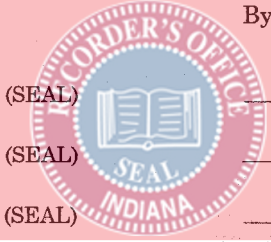
NOW THEREFORE, if the said Principal shall faithfully discharge and perform his duties as such

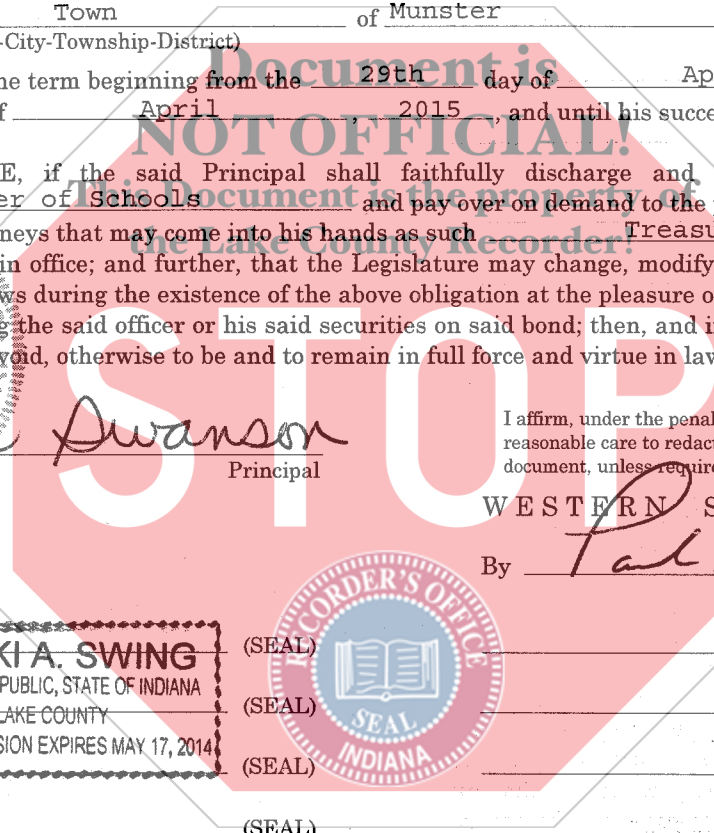

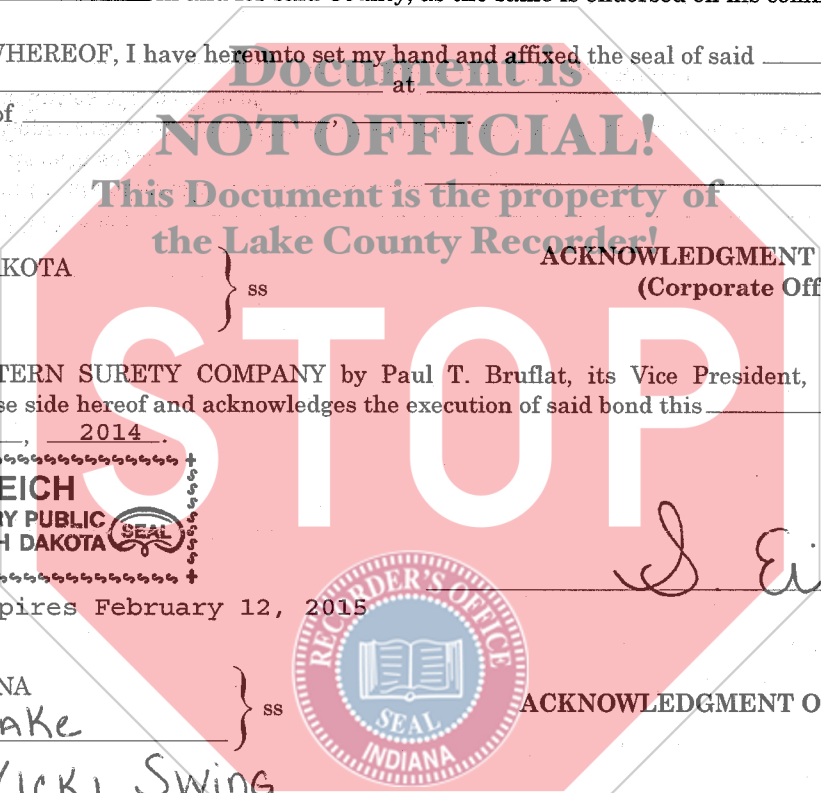

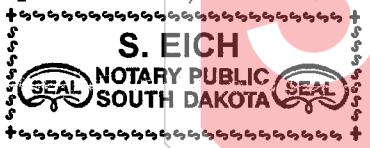
