POWER OF ATTORNEY

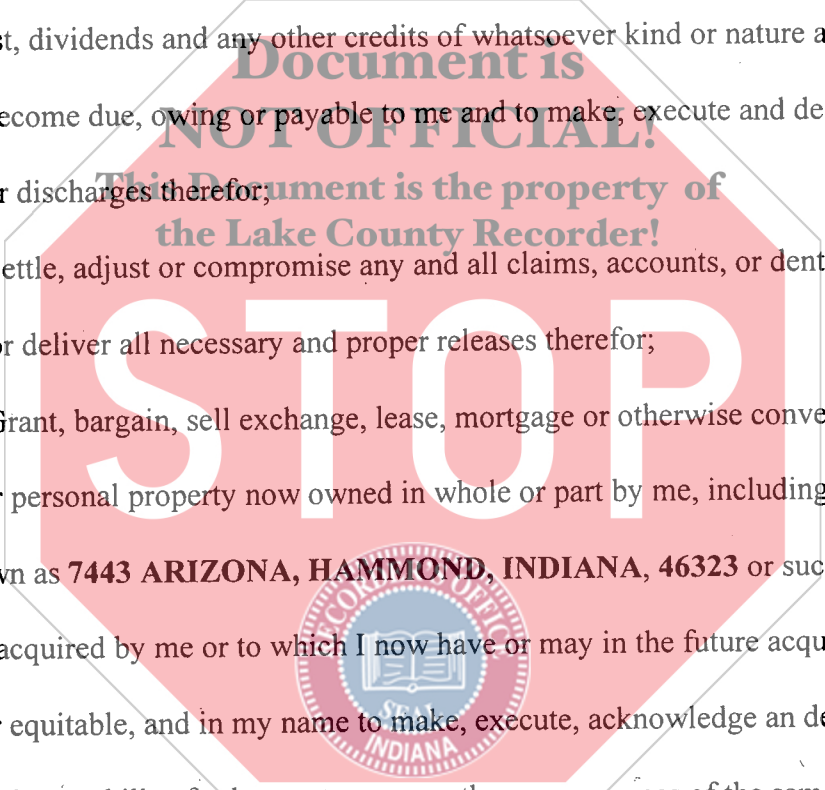

(e) Enter into my safe deposit box at any bank in which a safe deposit box is registered in my name and remove and take possession of securities, bonds or any other property in said safe deposit box;

(f) Pay any and all taxes, including income taxes, charges and assessments that may be assessed, imposed or levied by any governmental agency and in this connection to make and execute all income tax returns or other tax forms or returns;

(g) Execute vouchers in my behalf for any and all allowances and reimbursements properly payable to me by the United States; and to receive, endorse, and collect the proceeds of checks payable to the undersigned or to her order drawn on the Treasury of the United States;

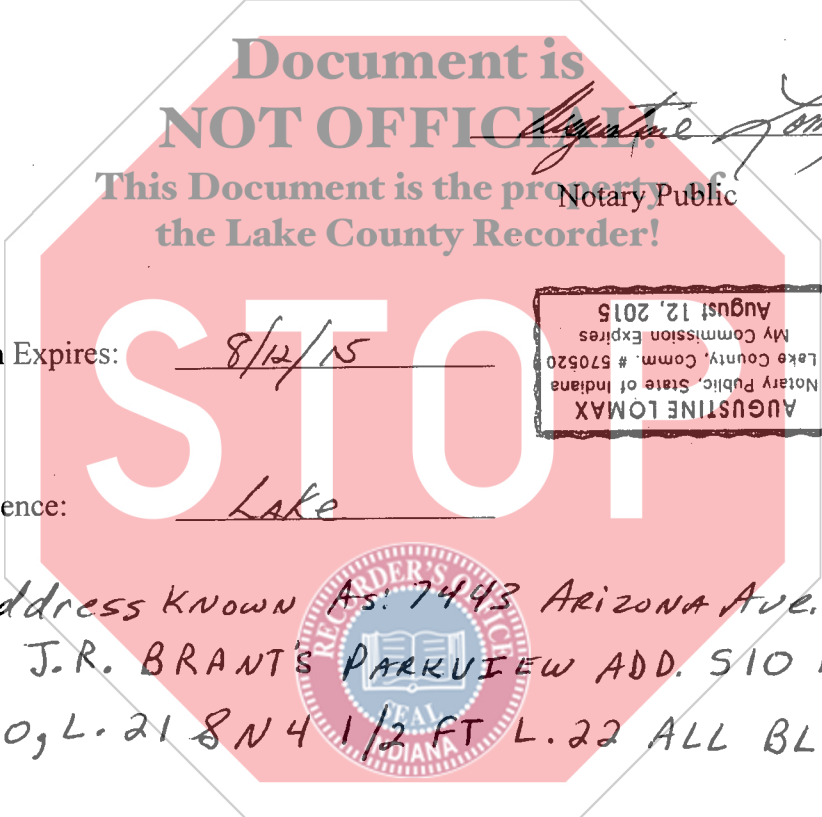

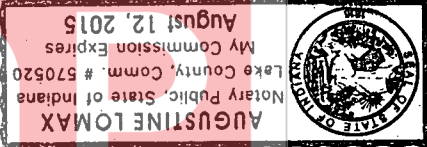
