Subject to covenants, restrictions and easements of record.

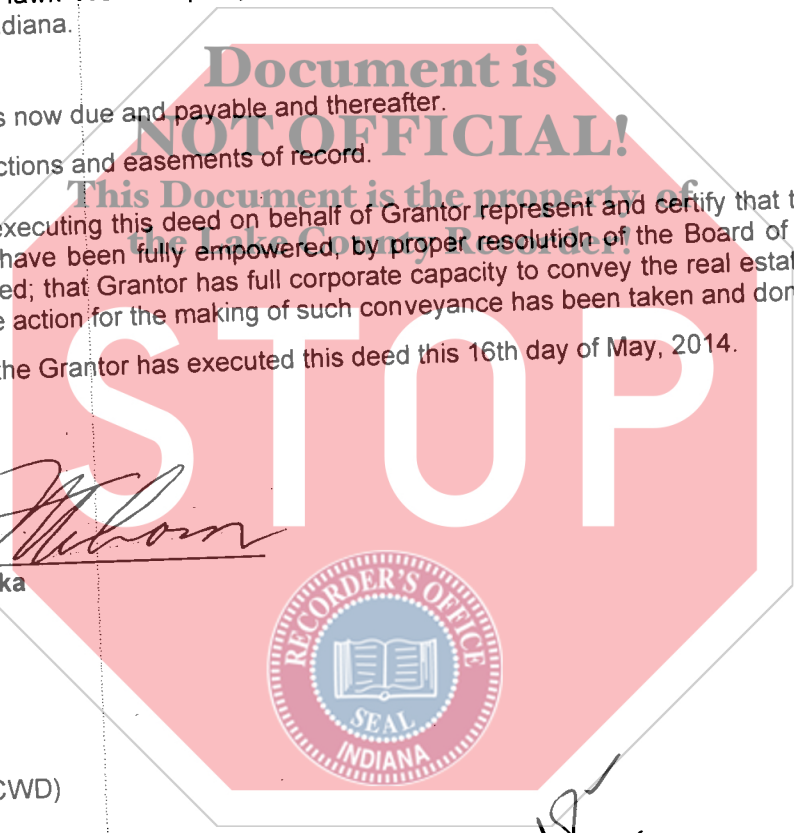
