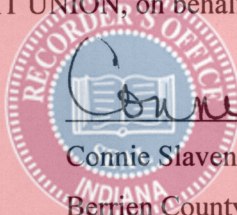

LEGAL DESCRIPTION

Parcel 1: The East 660 feet of the North 12 Acres of the East half of the Southwest Quarter of Section 28, Township 33 North, Range 8 West of the Second Principal Meridian in Lake County, Indiana, except the North 198 feet thereof.

Parcel 2: Part of the East half of the Southwest Quarter of Section 28, Township 33 North, Range 8 West of the Second Principal Meridian described as follows: Beginning at the Northeast corner of said Southwest Quarter, thence South along the East line of said Quarter Section, 198 feet; thence West 660 feet; thence North 198 feet to the North line of said Quarter Section; thence East along the north line of said Quarter Section 660 feet to the point of beginning, excepting therefrom a parcel of land beginning at the Northeast corner of said Southwest Quarter, thence South along the East line of said Quarter Section, 198 feet; thence West 220 feet; thence North 198 feet to the North line of said Quarter Section, 220 feet to the point of beginning, in Lake County, Indiana.

Parcel 3: The North 12 acres of the East half of the Southwest Quarter of Section 28, Township 33 North, Range 8 West of the Second Principal Meridian, in Lake County, Indiana, except the following described part thereof; Beginning at the Northeast corner of said Southwest Quarter; thence South, along the East line of said Quarter Section, 198 feet; thence West 220 feet; thence North 198 feet to the North line of said Quarter Section; thence East, along the North line of said Quarter Section, 220 feet to the point of beginning, also except the East 660 feet of the South 198 feet thereof.
