The Crown Point, Indiana Board of Public Works & Safety at its regularly scheduled meeting of May 9, 2012 at 9:00 A.M. heard evidence and testimony from Petitioner, Jerry Lambert, on his Petition for Disannexation filed before the Board on March 21, 2012. At this meeting it was determined by the Board of Public Works and Safety that:

1. Notice of the Petition was properly given pursuant to I.C. 5-3-1.
2. The Petitioner was appearing Pro Se.
3. That the Petitioner has agreed to pay all amounts due pursuant to the statements he received for City services.
4. That Petitioner provided proof of payments to the Board.
5. That Petitioner is not seeking any re-imbursement for moneys paid to the City.
6. That Petitioner is waiving any claim for damages.
7. That should the Board grant his Petition for Disannexation from the City, Petitioner would have no objection in the future, as City services become available to his property, to being reannexed by the City.
8. That Petitioner's Petition for Disannexation should be granted in part and denied in part.
9. That the just and equitable action by the Board would be to grant the Petition as it applies to the following Parcel Numbers. See Attached Exhibits.

10. That Board should deny the request as it applies to Parcel Number 45-16-24-100-002.000-047 for the reason that said parcel is located in Winfield Corp.

**WHEREFORE, IT IS THEREFORE ORDERED ADJUDGED AND DECREED THAT:** the Crown Point, Indiana Board of Public Works and Safety by a vote of 5-0 does hereby disannex the Parcel Numbers described and evidenced by their attachment hereto effective as provided by law.
